CHANGES TO EXPENSE RECOVERY COSTS

BlackRock Investment Management (Australia) Limited (**BlackRock**) is the Responsible Entity for the Australian-domiciled funds listed in Appendix 1 (**Funds**).

BlackRock hereby notifies investors that its approach to attributing expenses to the Funds has changed and that it may now recover costs for:

- certain out-of-pocket expenses incurred during the day-to-day operations of a Fund that BlackRock as the Responsible Entity is entitled to recover from each Fund; and
- other expenses that are incurred due to abnormal events (such as the cost of running a unitholder meeting or legal costs incurred by changes to a Fund's constitution or defending legal proceedings).

The above change has been reflected in any applicable product disclosure statements for the Funds. Any costs expensed to a Fund in a financial year will be disclosed as indirect costs in the Fund's management fees and costs for that financial year in applicable product disclosure statements and periodic statements.

Previously, unless indicated otherwise, all Fund expenses, other than disclosed indirect costs and transaction costs, were paid for by BlackRock as the Responsible Entity and no additional day-to-day expenses were recovered from a Fund.
