

## INVESTMENT OBJECTIVE

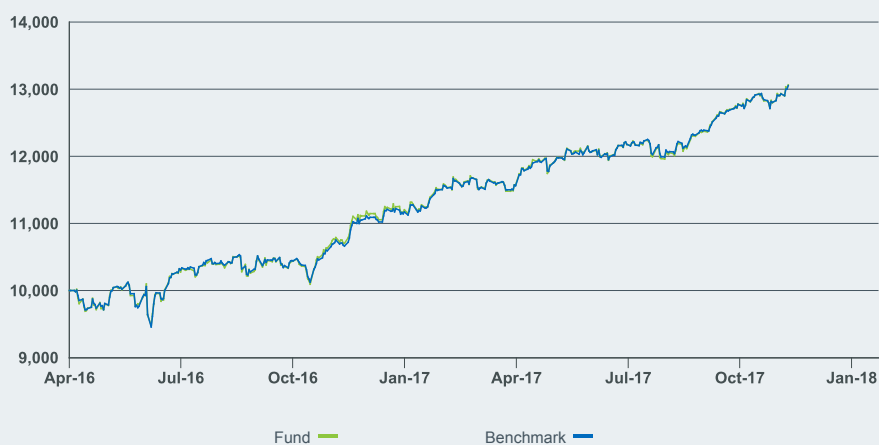

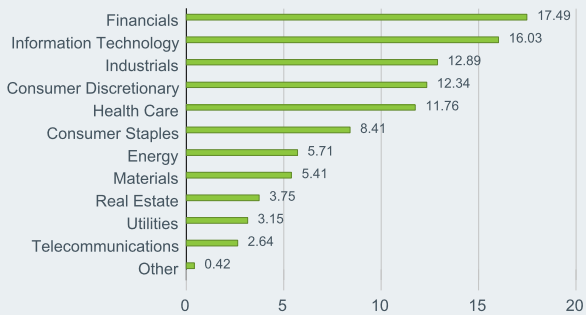

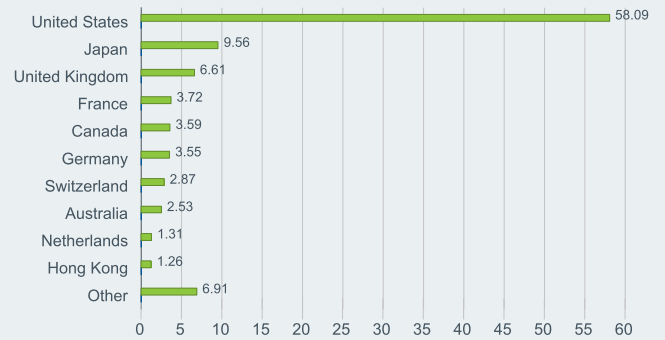
