Special Rates and Conditions

Guide for Completing Form W-8BEN (Individual i.e. not an Entity)

Instructions for Completing Form W-8BEN (beneficial owner is an individual)

In addition to these instructions please refer to the back of the Form W-8BEN ("Form") for guidance.

If the beneficial owner is an entity (i.e. not an individual) use Form W-8BEN-E. This Form W-8BEN will apply only to the securityholding in the listed entity shown on the form. If securities are held in other listed entities that solicit a Form W-8BEN, a separate form is required for each entity.

Part I – Identification of Beneficial Owner

Check the box if the beneficial owner is the same as the registered holder. If the name on the form is not the beneficial owner, a W-8IMY form is required from the registered holder and other U.S. tax forms (such as W-8BEN or W-8BEN-E) are required from the beneficial owners together with a withholding statement. These documents can be found at www-au.computershare.com/investor/Company

Check the box if your permanent residence address is the same as the registered holder's mailing address.

Permanent Residence Address
