


INVESTMENT OBJECTIVE

The fund aims to provide investors with the performance of the MSCI World ex Australia Quality Sector Capped Select 100% AUD Hedged Index, before fees and expenses. The index is designed to measure the AUD hedged performance of global, developed market large and mid-capitalisation companies with higher quality characteristics as identified through certain fundamental metrics.

WHY IHQL?

- 1 Seek Australian dollar hedged exposure to large and mid-cap developed markets companies outside Australia with higher quality characteristics: higher profitability, lower leverage, consistent earnings growth
- 2 Seek factor-driven outperformance over the long term
- 3 Sector constrained approach aims to avoid material over or under allocation to particular sectors
- 4 Access a factor that has historically performed best during an economic slowdown and contraction






