





INVESTMENT OBJECTIVE

The fund aims to provide investors with the performance of the STOXX Developed World Equity Factor Index, before fees and expenses. The index is designed to measure the performance of developed market equities that have favourable exposure to five target style factors subject to constraints.

WHY WDMF?

- 1 Low cost, diversified access to a portfolio of global developed market large and mid-cap stocks that tilts towards five historical drivers of returns – value, quality, momentum, low volatility and size
- 2 Seek factor-driven outperformance over the long term
- 3 Seek to enhance the core of your portfolio by maximising exposure to factors while maintaining a similar level of risk to the broader parent index



MSCI ESG Quality Score (0-10): The MSCI ESG Quality Score (0 - 10) for funds is calculated using the weighted average of the ESG scores of fund holdings. MSCI rates underlying holdings according to their exposure to industry specific ESG risks and their ability to manage those risks relative to peers.
