This means that the final day on which you can submit a dealing instruction to make a new subscription into the Fund will be 12 noon Luxembourg time on 6<sup>th</sup> November 2026 in accordance with the instructions disclosed in the Prospectus.

The Investment Period will therefore begin immediately on 9 November 2026 and close on 8 November 2030 upon which the Fund will enter its Post Investment Period.


