Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

1895 Wereld Bedrijfsobligaties Fonds (the "Fund"), Class D Dist EUR (the "Unit Class"), ISIN: NL0015436049, is authorised in The Netherlands and manufactured by BlackRock Asset Management Ireland Limited (the "Manager") which is part of the BlackRock, Inc group. The Manager is authorised in Ireland and regulated by the Central Bank of Ireland (CBI). The Manager is also licensed in the Netherlands by the Dutch Authority for the Financial Markets (AFM) to act as the manager of the Fund and the AFM is responsible for supervising the Manager in relation to this Key Information Document.

What is this product?

Type: The Fund is a sub-fund of 1895 Fonds FGR established under the laws of The Netherlands, authorised by the Netherlands Authority for the Financial Markets as a Undertaking for Collective Investment in Transferable Securities ("UCITS").

Term: The Fund does not have a fixed term of existence or maturity period but in certain circumstances, as described in the Fund prospectus, the Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

Objectives

- The Fund aims to achieve a return on your investment over a period of at least 5 years, through a combination of capital growth and income on the Fund's assets, whilst also seeking to outperform the Bloomberg Global Aggregate Corporate Index (EUR Hedged) (75%) and the Bloomberg MSCI Global Green Bond Corporate 5% Issuer Cap Index (EUR Hedged) (25%) (the "Index"). The Fund also seeks to invest in a manner consistent with the principles of environmental, social and governance ("ESG") investing.
- The Fund will seek to invest 80% of its assets in fixed income (FI) securities (e.g. bonds) and fixed income-related securities of issuers worldwide.
- The Fund's investments will normally be listed or traded on regulated markets. The Fund may also invest in other FI securities (such as bonds issued by Economic and Monetary Union ("EMU") and non-EMU governments and government agencies and supranational bonds domiciled in and outside the European Union) in order to achieve a similar return to the Index in a cost efficient manner. All FI securities in which the Fund invests will be investment grade rated by Moody's, Standard & Poor's Corporation or Fitch Ratings at the time of purchase or are deemed by the Investment Manager ("IM") to be of an equivalent rating.
- The Fund may also invest in collective investment schemes (i.e. other investment funds which may be associated with the IM), derivatives, cash and money market instruments (i.e. debt securities with short-term maturities). Through these asset classes, the Fund may obtain indirect exposure to issuers that are inconsistent with the IM's ESG Policy.
- The Fund may use of financial derivative instruments ("FDIs") (i.e. investments the prices of which are based on one or more underlying assets) for direct investment purposes and for efficient portfolio management.
- The IM may invest the Funds' assets in accordance with its ESG Policy as disclosed in the prospectus and the BlackRock website at: https://www.blackrock.com/nl/particuliere-beleggers/literature/prospectus/1895-fonds-fgr-esg-policy.pdf.
- The Fund is actively managed, and the IM has discretion to select the Fund's investments.
- The price of FI securities may be affected by changing interest rates which in turn may affect the value of your investment. FI securities prices move inversely to interest rates. Therefore, the market value of FI securities may decrease as interest rates increase. The credit rating of an issuing entity will generally affect the yield that can be earned on FI securities; the better the credit rating the smaller the yield.
- The return on your investment in the Fund is directly related to the value of the underlying assets of the Fund, less costs (see "What are the costs?" below).
- The relationship between the return on your investment, how it is impacted and the period for which you hold your investment is considered below (see "How long should I hold it and can I take my money out early?").
- The depositary of the Fund is The Bank of New York Mellon SA/NV. Amsterdam Branch.

- · Your units will be distributing units (i.e. dividend income will be paid semi-annually).
- Your units will be denominated in Euro, the Fund's base currency.
- You can buy and sell your units daily. The minimum initial investment for this unit class is €50,000,000.

Intended retail investor: The Fund is intended for retail investors with the ability to bear losses up to the amount invested in the Fund (see "How long should I hold it and can I take my money out early?").

Insurance benefits: The Fund does not offer any insurance benefits.

What happens if BlackRock Asset Management Ireland Limited is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary, The Bank of New York Mellon SA/NV, Amsterdam Branch (the "Depositary"). However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. What are the costs?
