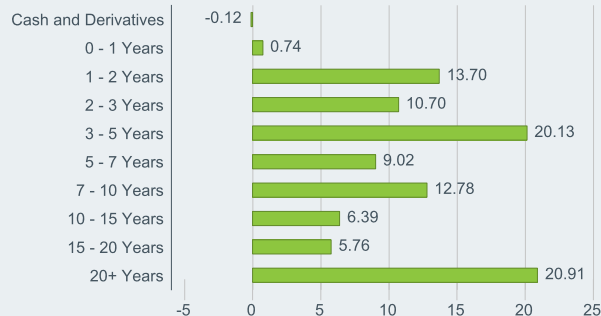

MATURITY BREAKDOWN (%)



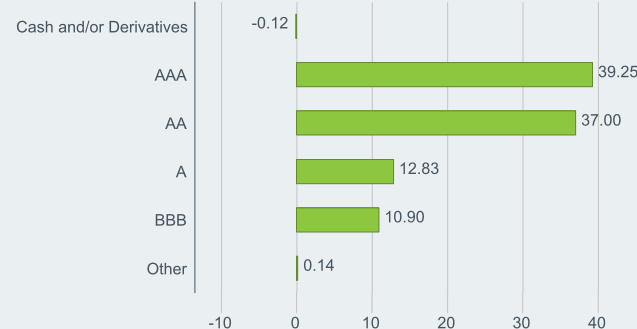
