## Management Discussion of Fund Performance

BlackRock Asset Management Canada Limited ("BlackRock Canada") is pleased to provide you with the Management Report of Fund Performance ("MRFP") for the iShares Bitcoin ETF (the "Fund") for the period ended December 31, 2025. You and your financial advisor can use this information along with the annual financial statements of the Fund to assess the Fund's performance and how your investment in the Fund aligns with your overall financial plan.

The Fund is an exchange-traded fund which trades on the Cboe Canada (the "Exchange"). Investors typically buy and sell units of the Fund through a brokerage account. The Fund's Exchange ticker symbol is IBIT for the Canadian dollar denominated units ("CAD Units") and IBIT.U for the U.S. dollar denominated units ("USD Units").

References to "net assets" or "net assets per unit" in this MRFP are references to net assets attributable to holders of redeemable units determined in accordance with the International Financial Reporting Standards, as issued by the International Accounting Standards Board ("IFRS Accounting Standards") as presented in the Fund's financial statements. All references to "net asset value" or "net asset value per unit" in this MRFP are references to net asset value determined in accordance with National Instrument 81-106 – *Investment Fund Continuous Disclosure* which is used for all purposes except for the financial statements, including for Fund pricing purposes in connection with subscriptions, exchanges and redemptions.

## Investment Objective and Strategies

The Fund seeks to reflect generally the performance of the price of bitcoin, before payment of the Fund's expenses and liabilities. Under normal market conditions, the Fund will primarily invest all or substantially all of its assets in U.S. IBIT. U.S. IBIT invests in and holds substantially all of its assets in long-term holdings of bitcoin.

The Fund is considered to be an "alternative mutual fund" because it has adopted investment objectives and strategies that are not permitted for conventional mutual funds, specifically, to seek to reflect generally the performance of the price of the digital asset bitcoin, before payment of Fund's expenses and liabilities. The Fund will not speculate with regard to short-term changes in bitcoin prices. The Fund does not currently intend to invest in derivatives, engage in short selling, nor borrow cash for investment purposes. Any such activities will be made in accordance with the applicable restrictions to alternative mutual funds under NI 81-102.

## Risk

The risks of investing in the Fund are described in the prospectus. There have been no changes to the Fund since the commencement of the Fund on January 8, 2025 that materially affected the risk level of the Fund.

## Results of Operations

The Fund commenced operations on January 8, 2025. The Fund's net asset value was \$378.3 million at December 31, 2025, which represents an increase of \$453.6 million due to net subscriptions to the Fund and a decrease of \$75.3 million due to investment operations less distributions paid.

The Fund has a distribution policy that requires it to distribute sufficient net income and net realized capital gains so that it will not be liable to pay income tax under Part I of the *Income Tax Act* (Canada). Amounts included in the calculation of net income and net realized capital gains of the Fund for a taxation year, that must be distributed in accordance with the distribution policy, sometimes include amounts that have not actually been received by the Fund.

The Fund may borrow cash in accordance with the restrictions in National Instrument 81-102 – *Investment Funds*, and, in accordance with the terms of exemptive relief, as a temporary measure to fund the portion of any distributions payable to unitholders that represents amounts that have not yet been received by the Fund. Pursuant to such relief, the borrowing may not be for a period longer than 45 days, and the Fund is limited to borrowing up to the amount of the distribution that is payable to, but has not yet been received, by the Fund and, in any event, not more than 5% of the net assets of the Fund. For the period ended December 31, 2025, the Fund did not borrow any cash.

The Fund is an "alternative mutual fund" for securities law purposes. Accordingly, the Fund has the ability to invest in asset classes and use investment strategies that are not permitted for conventional mutual funds, such as the ability to employ leverage through cash borrowings, short sales and/or derivatives beyond the limits prescribed for conventional mutual funds. Leverage may be created through the use of cash borrowings, short sales and/or derivatives. An alternative mutual fund's aggregate exposure to those sources of leverage may be up to 300% of its NAV.

## Recent Developments

### ***Independent Review Committee ("IRC") Appointments & Resignations***

Effective June 1, 2025, Cathy Welling replaced Geoffrey Creighton as the Chair of the IRC.

Effective November 30, 2025, Geoffrey Creighton ceased to be a member of the IRC.

Effective December 1, 2025, Peter von Schilling and Jane Waechter were appointed as members of the IRC.

## Related Party Transactions

### ***Trustee, Manager and Portfolio Advisor***

BlackRock Canada, an indirect, wholly-owned subsidiary of BlackRock, Inc. ("BlackRock"), is the trustee, manager, and portfolio advisor of the Fund and is responsible for the day-to-day administration of the Fund. The Fund pays annual management fees to BlackRock Canada as consideration for its services. In addition, BlackRock Canada and/or an affiliate, as applicable, acts as trustee or manager of any iShares ETF in which the Fund invests.

The Fund is permitted to purchase, sell and hold securities of certain issuers that are directly or indirectly related to BlackRock Canada (currently including, but not limited to, BlackRock). With respect to investment in related issuers, BlackRock Canada has relied on the approval that it has received from the IRC. The approval requires BlackRock Canada to comply with its current policy and procedures regarding investments in related issuers and to report periodically to the IRC.

The Fund may execute inter-fund trades. Inter-fund trading is the buying and selling of portfolio securities between funds for which BlackRock Canada serves as trustee and manager and managed accounts to which BlackRock Canada serves as manager. With respect to inter-fund trades, BlackRock Canada has relied on the approval that it has received from the IRC. The approval requires BlackRock Canada to comply with its current policy and procedures regarding inter-fund trading and to report periodically to the IRC.

BlackRock Canada has agreed to be responsible for the fees and expenses of the Fund except the annual management fees, any fees and expenses related to the operation of the IRC under National Instrument 81-107 - *Independent Review Committee for Investment Funds*, brokerage expenses and commissions and other portfolio transaction costs, income tax, harmonized sales tax ("HST"), and withholding and other taxes. The Fund is also responsible for other fees and expenses in accordance with the terms of its trust document, such as extraordinary expenses or expenses incurred in connection with the recovery of amounts due to the Fund, as applicable.

### **Securities Lending Agents**

The Fund has engaged BlackRock Institutional Trust Company, N.A. ("BTC") and BlackRock Advisors (UK) Limited ("BRAL"), affiliates of BlackRock Canada, as securities lending agents. To mitigate risks from securities lending, the Fund benefits from a borrower default indemnity provided by BlackRock, an affiliate of BlackRock Canada. BlackRock's indemnity allows for full replacement of securities lent in the event that the borrower defaults on its obligation to return the loaned securities and collateral received is insufficient to reconstitute the portfolio of loaned securities. BTC and/or BRAL bear all operational costs directly related to securities lending as well as the cost of borrower default indemnification. The Fund did not engage in securities lending activities during the period ended December 31, 2025.

BlackRock Canada relies on a positive recommendation and standing instruction that it has received from the IRC with respect to the securities lending activities of the Fund, including the appointment of and payment to its affiliates as securities lending agents. The standing instruction requires BlackRock Canada to comply with its current policy and procedures regarding securities lending and to report periodically to the IRC.

### **Sub-Advisor**

BlackRock Canada has appointed its affiliate, BTC, as the sub-advisor of the Fund. As compensation for its services as sub-advisor, BlackRock Canada pays BTC a portion of the management fees paid by the Fund to BlackRock Canada.

### Management Fees

The management fees are calculated based on 0.32% per annum of the average daily net asset value of the Fund. The fees are accrued daily and are generally paid monthly, but in any case not less than quarterly. In addition, BlackRock Canada and/or an affiliate, as applicable, is entitled to receive management fees for acting as trustee or manager of any iShares ETF held by the Fund ("underlying product fees"). As the underlying product fees are embedded in the market value of any iShares ETF in which the Fund invests, the underlying product fees are paid indirectly by the Fund.

BlackRock Canada has adjusted the management fee payable by the Fund during the period to ensure that total annual fees paid directly and indirectly by the Fund to BlackRock Canada and/or its affiliate, as applicable, did not exceed 0.32% per annum (excluding GST and HST) of the Fund's net asset value.

For the period ended December 31, 2025, the Fund accrued, directly and indirectly, \$750,958 (excluding GST and HST in the amount of \$21,356) in total annual fees (management fees and underlying product fees of \$164,727 and \$586,231, respectively).

### Past Performance

The Fund commenced operations on January 8, 2025. Since the Fund has been a reporting issuer for less than a year, it is not permitted to provide the performance data for the period.
