Any orders under those limits will be sent without dual authorization requirements. This user can also approve another Trader or Trader/Approver's purchase and redemption orders.
- Approver only allows the user to approve a Trader with dual approval limits or a Trader/Approver with dual approval limit's purchase and redemption orders. This user cannot place purchase or redemption orders.
- Trader/Approver without dual approval limits (previously Superuser) allows the user to submit trades without a secondary approval. This user can approve a Trader or Trader/Approver's purchase and redemption orders.
