FUND OVERVIEW

- The Fund aims to achieve positive absolute returns through a combination of capital growth and income on your investment regardless of market conditions.
- The Fund seeks to gain at least 60% of its investment exposure to equity securities (e.g. shares) and equity-related securities of 'emerging' companies domiciled in, or the main business of which is in, or have their primary listing in, the UK.
- The Fund will invest at least 70% of its assets in equity securities and other equityrelated securities, including financial derivative instruments (FDIs) (i.e. investments
 whose prices are based on one or more underlying assets). The Fund may also, when
 determined appropriate, invest in fixed income (FI) securities, money market
 instruments (MMIs) (i.e. debt securities with short-term maturities), deposits and cash.

KEY RISKS:
