FUND OVERVIEW

- The Fund aims to maximise the return on your investment through a combination of capital growth and income on the Fund's assets.
- The Fund invests at least 70% of its total assets in the equity securities (e.g. shares) of companies domiciled in, or the main business of which is in, emerging European countries or the Mediterranean region (countries bordering the Mediterranean Sea).
- The Fund may indirectly invest in emerging markets by investing in American Depositary Receipts (ADRs) and Global Depositary Receipts (GDRs), which are listed or traded on stock exchanges and regulated markets outside emerging markets. ADRs and GDRs are investments issued by financial institutions which give exposure to underlying equity securities.

KEY RISKS:

- Emerging markets are generally more sensitive to economic and political conditions than developed markets. - Currency Risk: The Fund invests in other currencies. Changes in exchange rates will therefore affect the value of the investment.

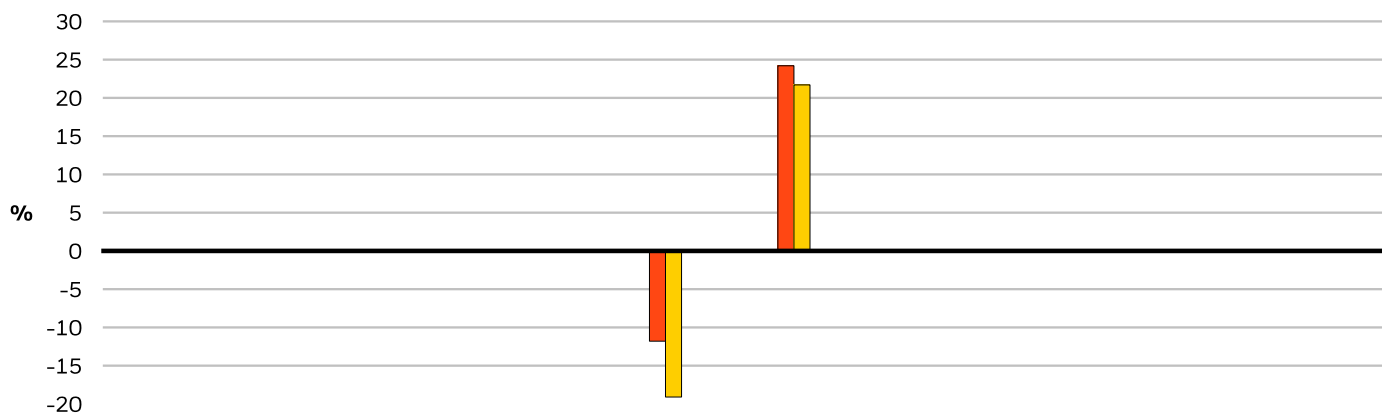

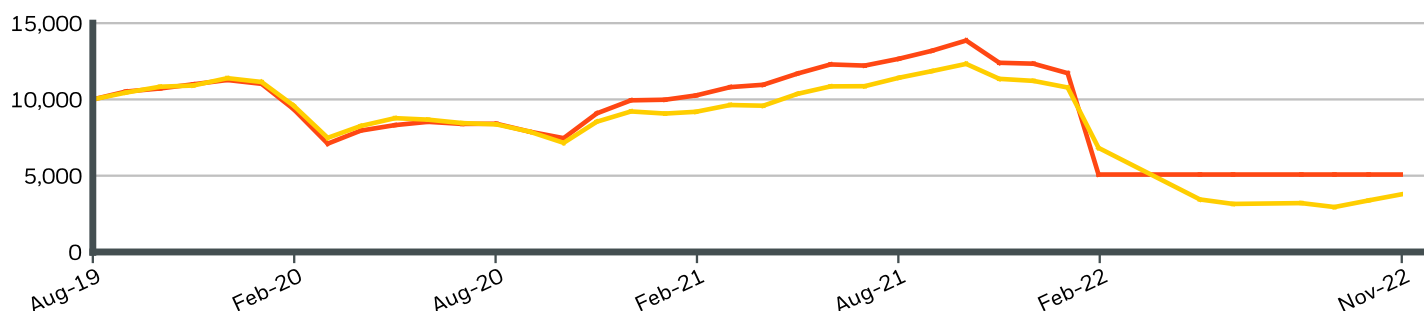

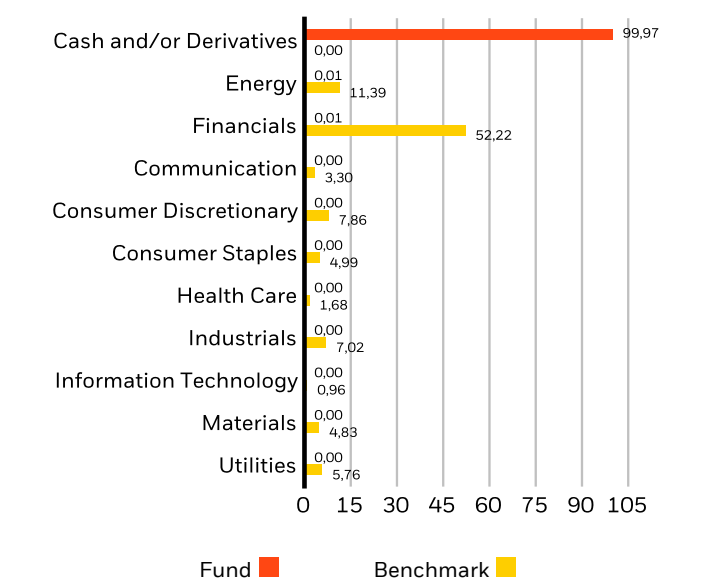

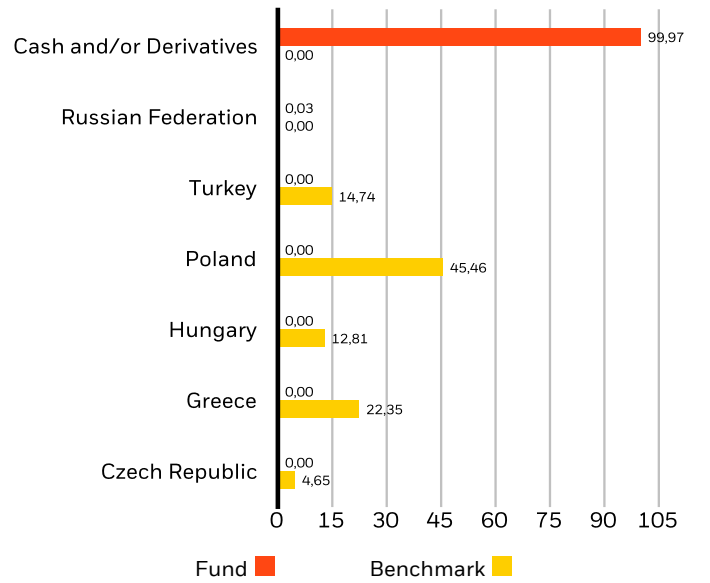

SECTOR BREAKDOWN (%)



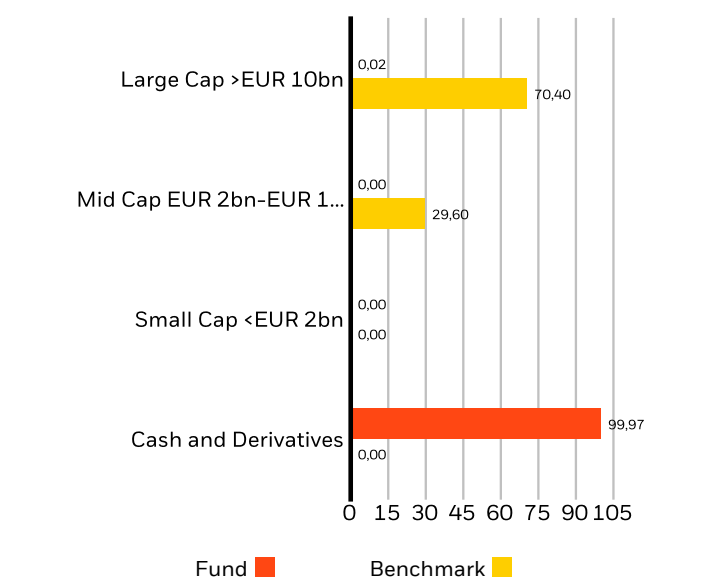
