FUND OVERVIEW

- The Fund aims to maximise the return on your investment through a combination of capital growth and income on the Fund's assets.
- The Fund invests at least 70% of its total assets in the equity securities of smaller capitalisation companies domiciled in or exercising the predominant part of their economic activity in developed markets which, in the opinion of the Investment Adviser (IA), have above- average growth prospects.
- Smaller capitalisation companies are those whose market capitalisations (market capitalisation is the share price of the company multiplied by the number of shares issued) are similar to those of companies in the Index (as defined below).

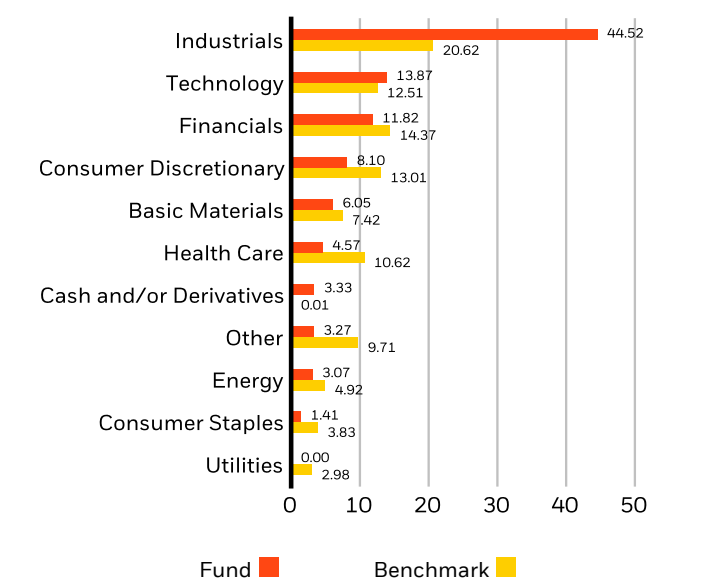

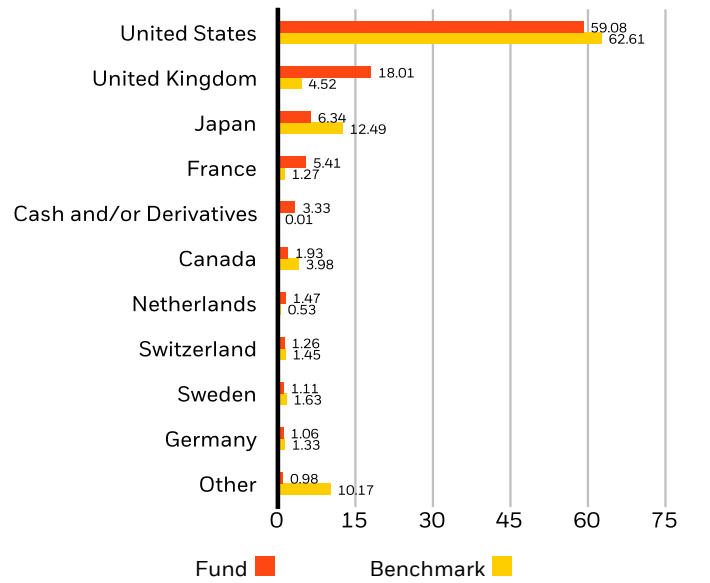

SECTOR BREAKDOWN (%)



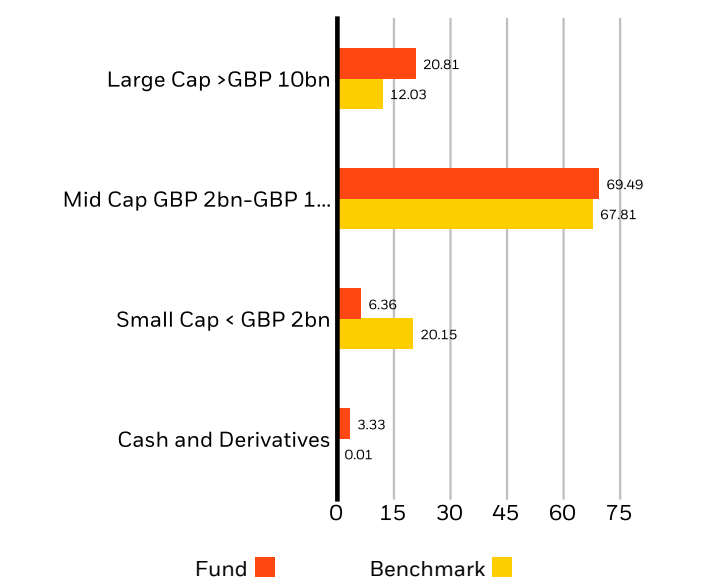
