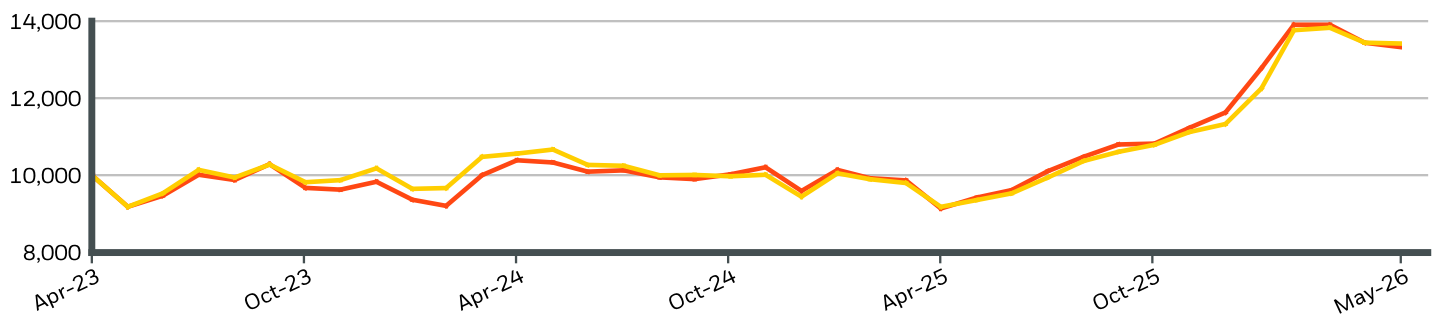

**SECTOR BREAKDOWN (%)**



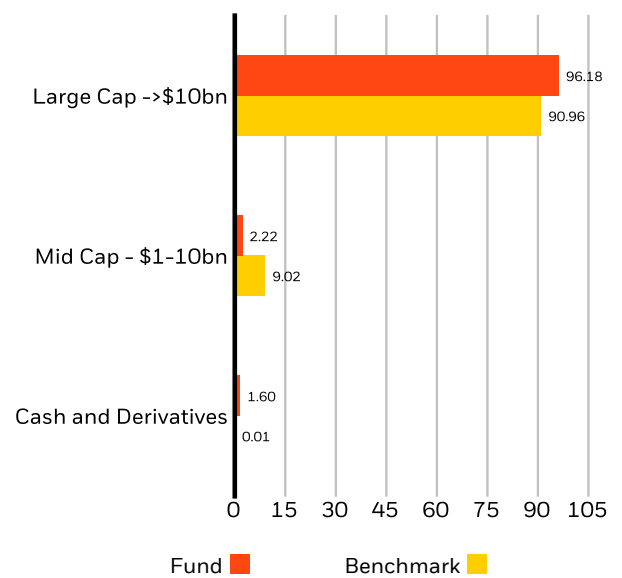
