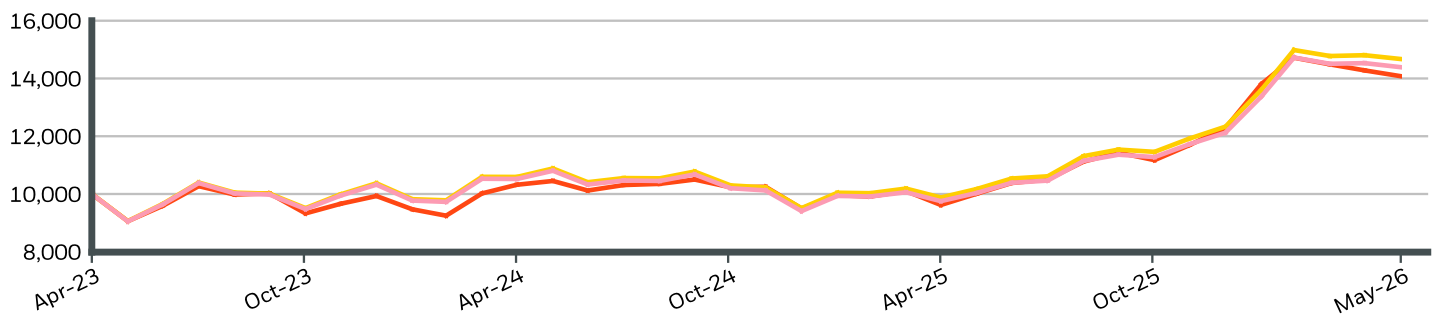

SECTOR BREAKDOWN (%)



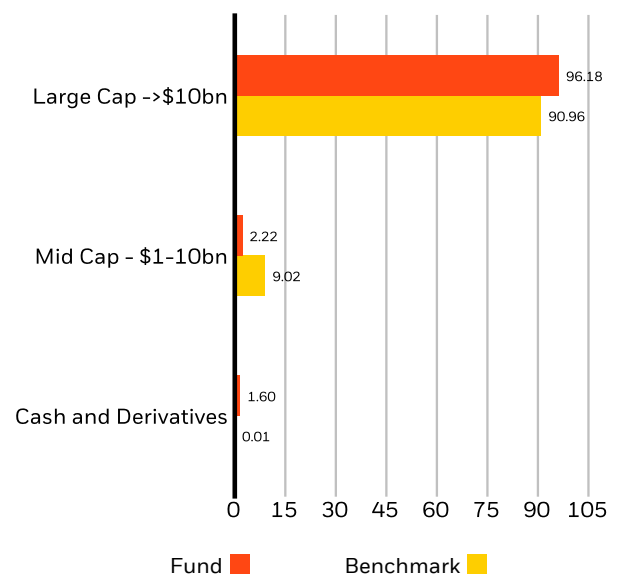
