- The Fund does not hold physical gold or metal.

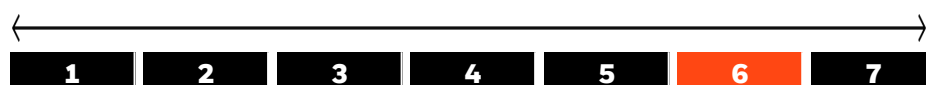

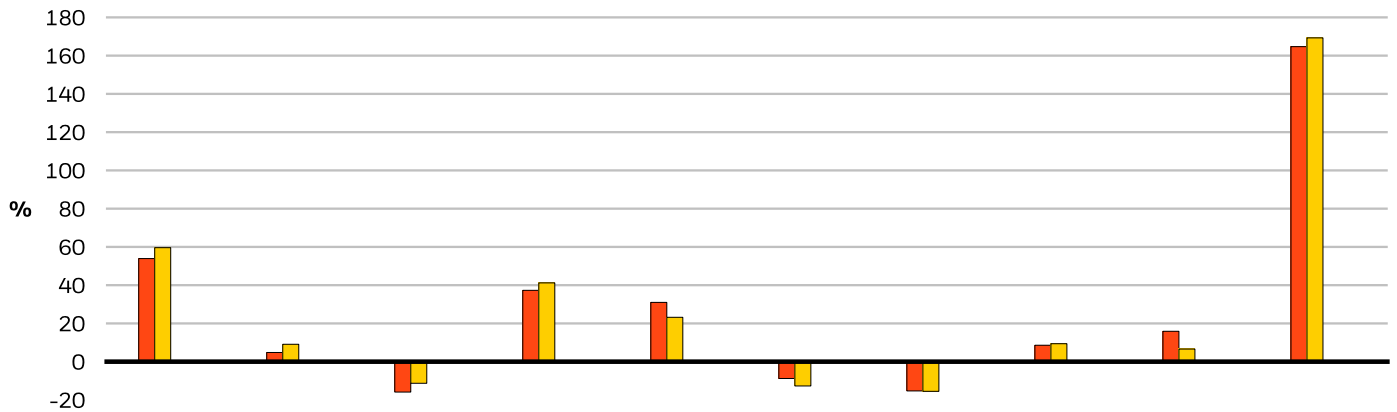

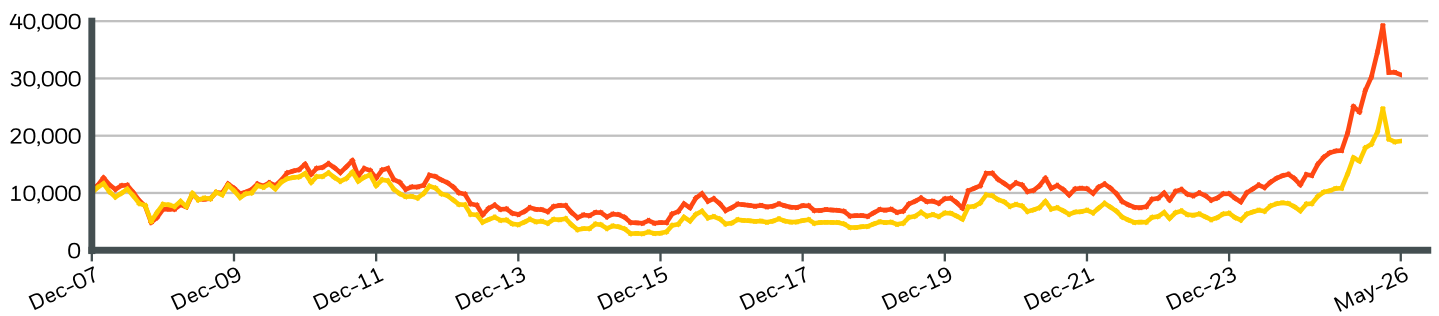

SECTOR BREAKDOWN (%)



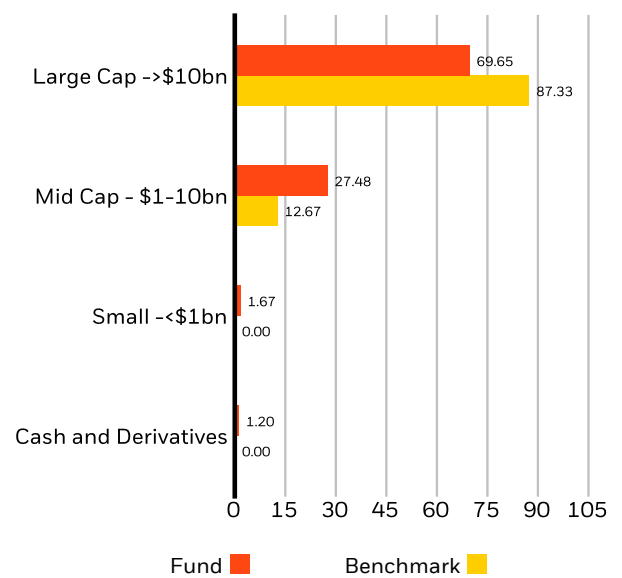
