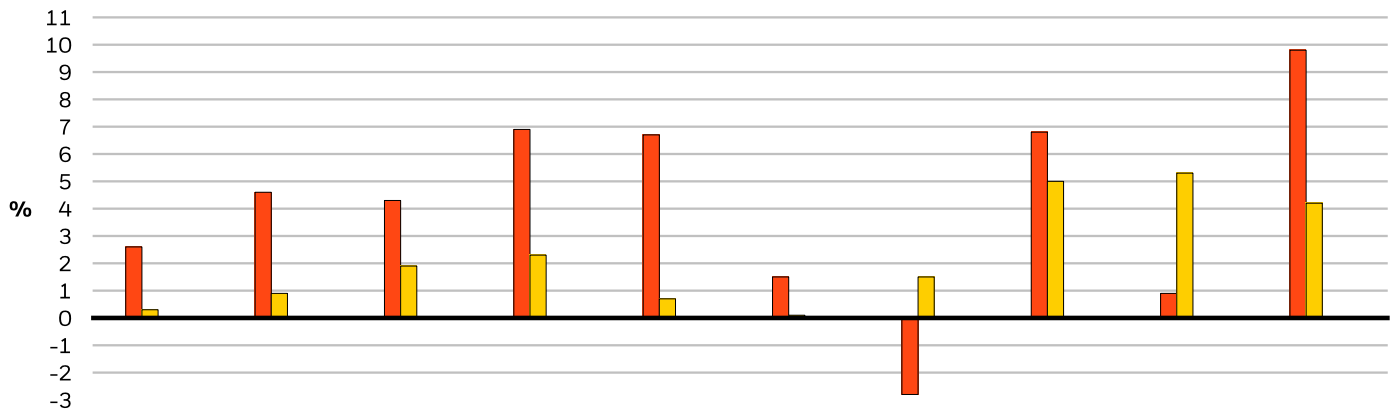


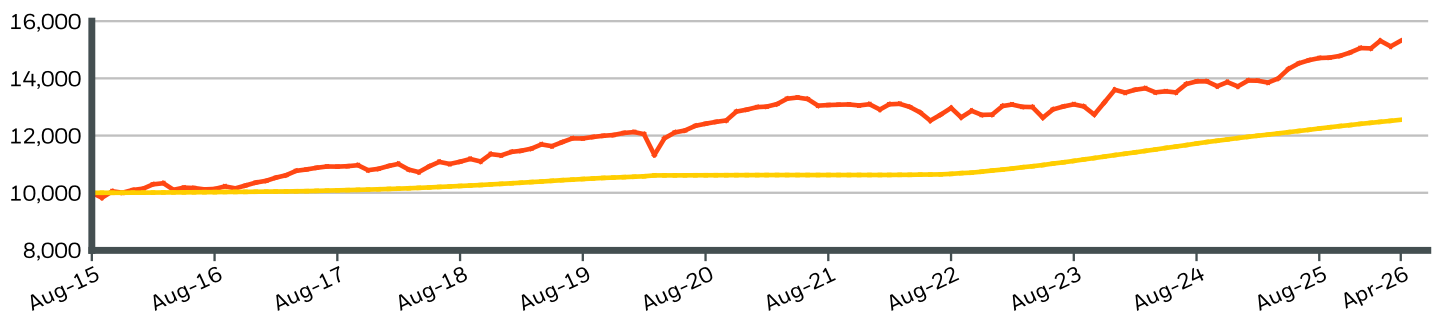

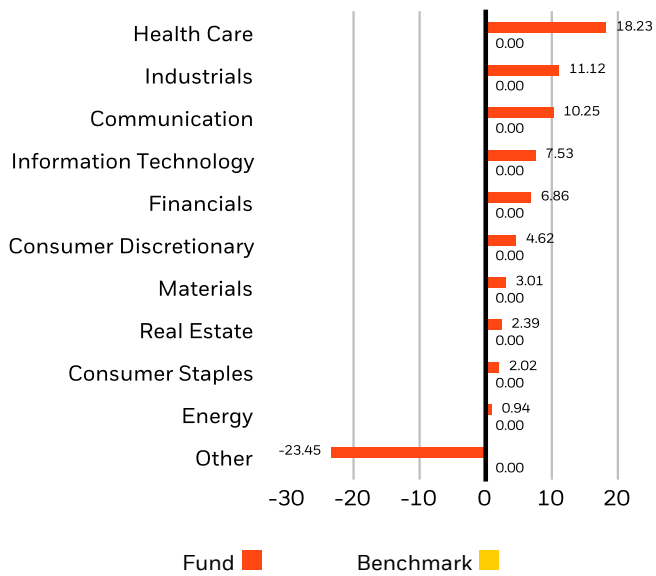

#### SECTOR BREAKDOWN (%)



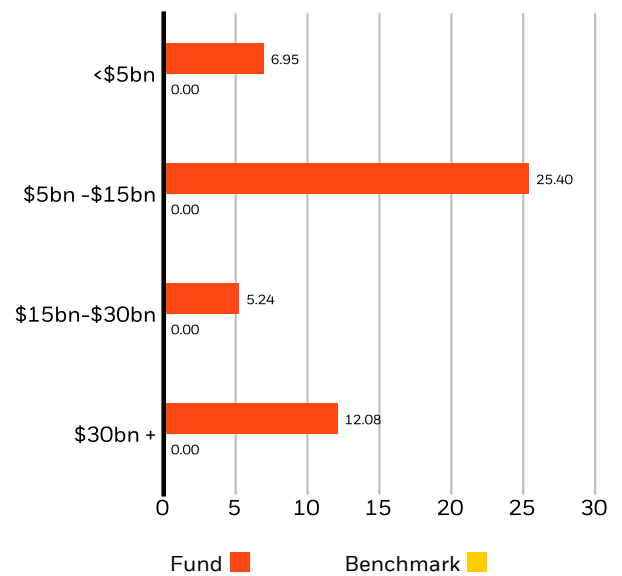

**Price to Book Ratio:** represents the ratio of the current closing price of the share to the latest quarter's book value per share.
