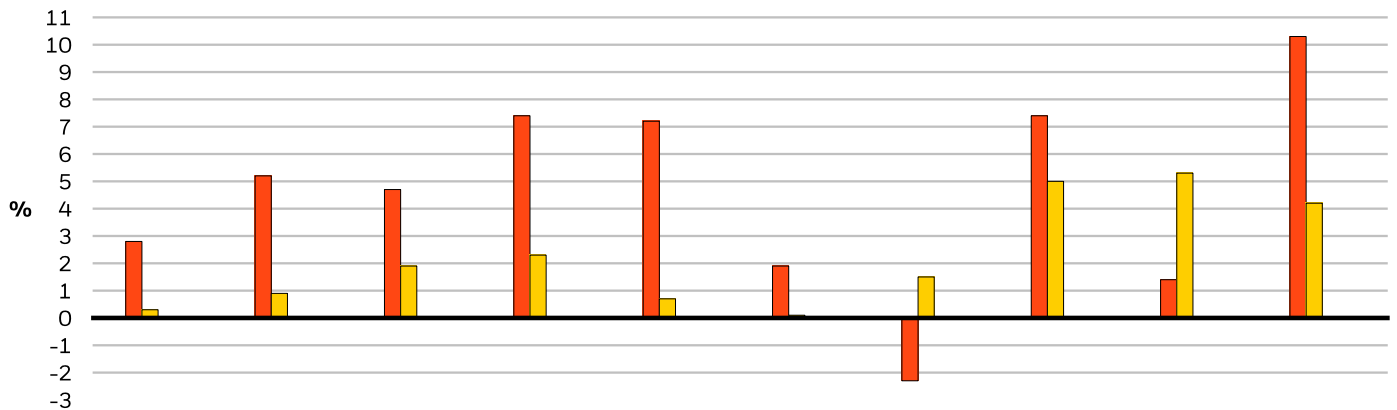
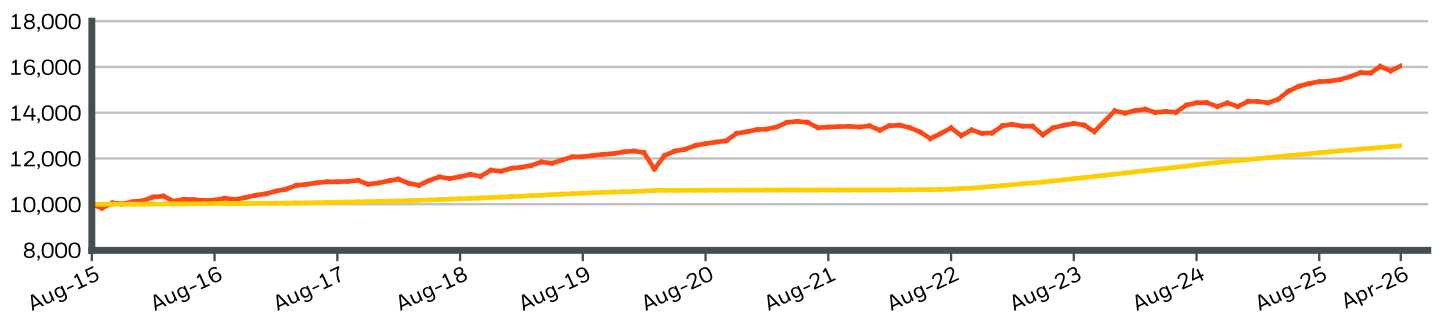

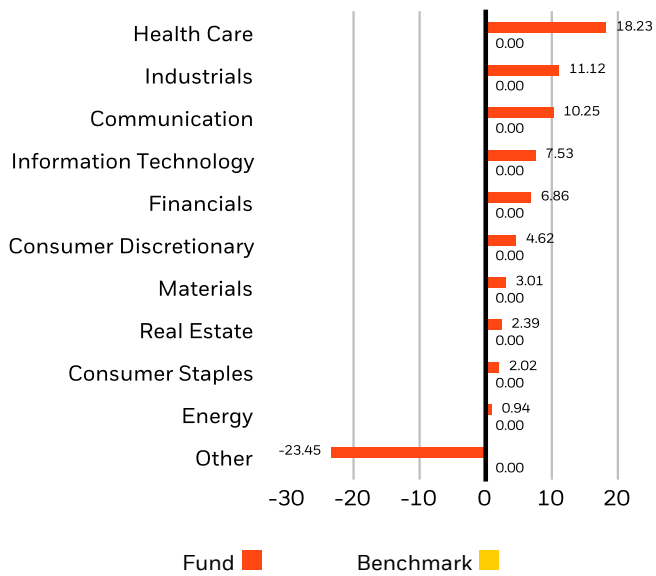

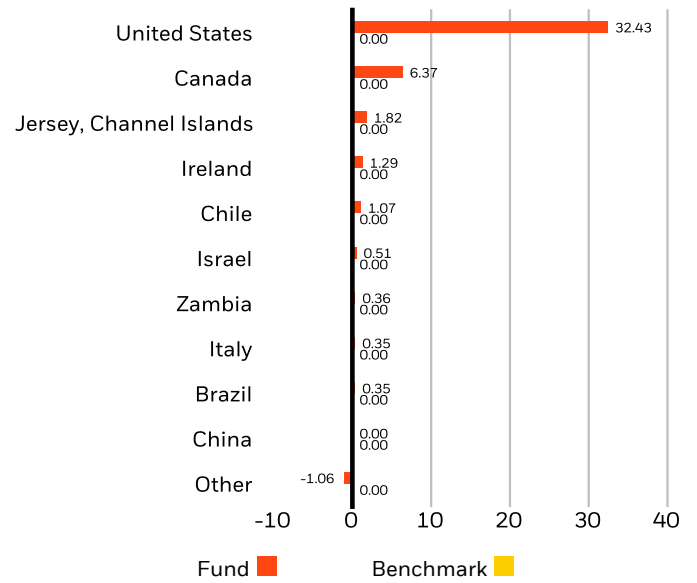

SECTOR BREAKDOWN (%)



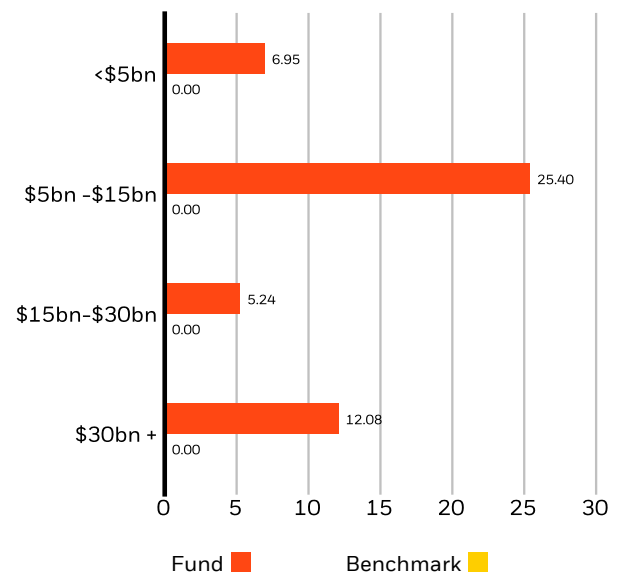
