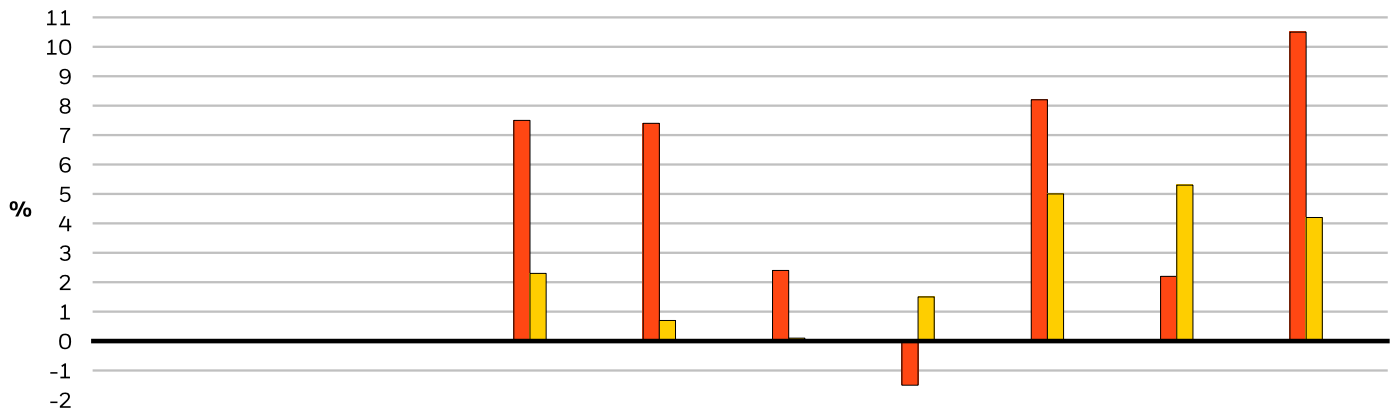


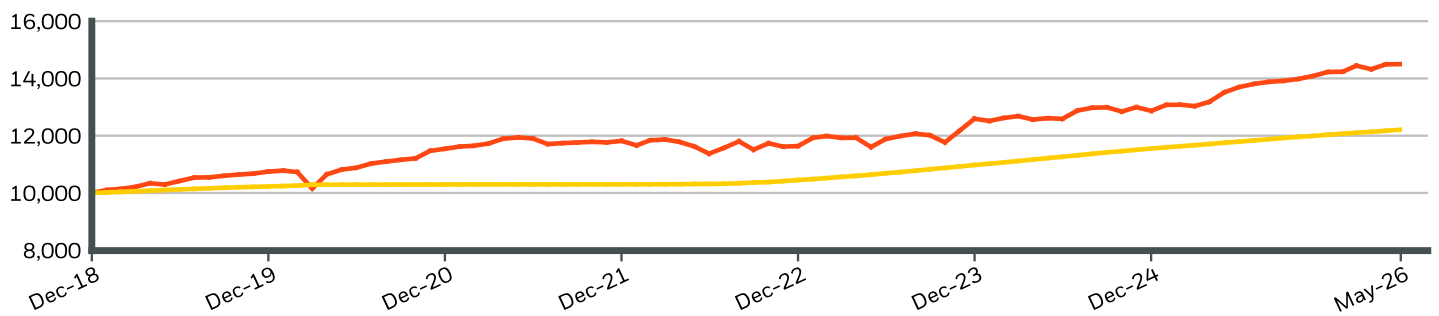

**SECTOR BREAKDOWN (%)**



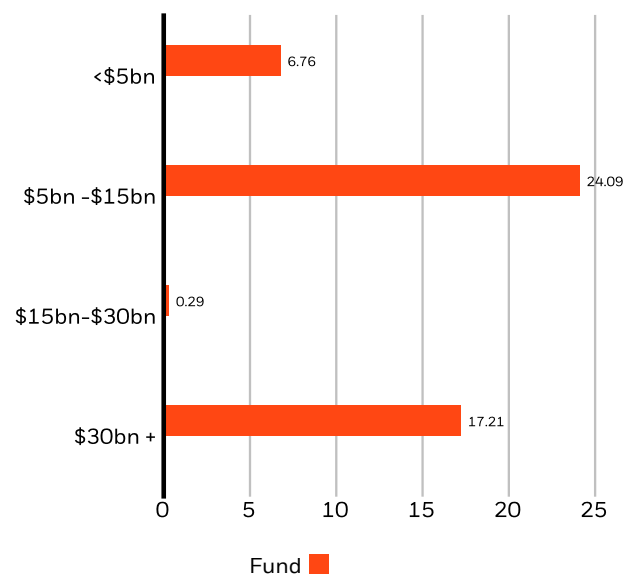
