

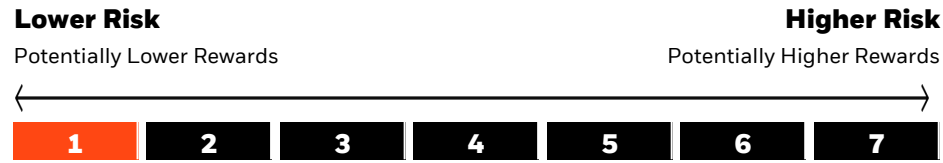

FUND OVERVIEW

- The Fund aims to invest at least 85% of its assets in Norsk Likviditet, a sub-fund of Danske Invest 2 SICAV, authorised as a UCITS fund in Luxembourg by the Commission de Surveillance du Secteur Financier (the Master Fund) and, as such, is designated as a “feeder fund” within the meaning given to that term in the UCITS Regulations.
- In addition to investing at least 85% of its assets into the Master Fund, the Fund may, also invest up to 15% of its assets, in aggregate, in the following other assets: 1) money market instruments (MMI) including bills, commercial paper and certificates of deposits for ancillary liquidity purposes; and (b) financial derivative instruments (FDI) for hedging purposes only.
- The Master Fund’s investment objective is to achieve above-market performance. It is an actively managed fixed income (FI) fund which primarily invests in Norwegian short-duration bonds, MMI and bank deposits, with at least two-thirds of its net assets invested in bonds or other debt securities issued by governments, municipalities and other public organisations, companies or credit institutions.

KEY RISKS:

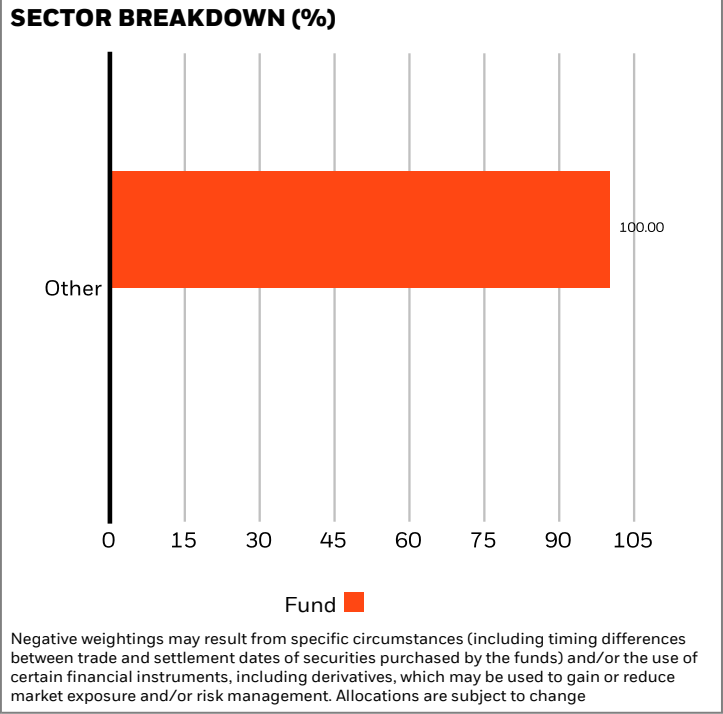
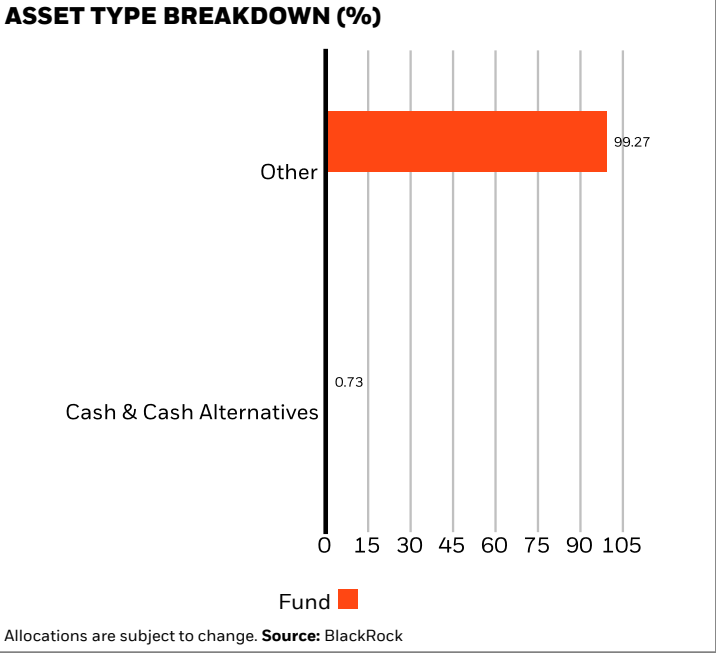

GLOSSARY

Modified Duration: A measure of price sensitivity of a bond to changes in interest rates. The Modified Duration of the fund is calculated as the average of the underlying bonds' modified duration values, adjusted to take account of their relative weight (size) within the fund.

Price to Earnings: A valuation ratio of a company's current share price compared to its per-share earnings in the current forecast year, calculated as current share price divided by current earnings per share.

Average Market Cap: The average market capitalization of a fund's equity portfolio gives you a measure of the size of the companies in which the fund invests. Market capitalization is calculated by multiplying the number of a company's shares outstanding by its price per share.

Price to Book Ratio: represents the ratio of the current closing price of the share to the latest quarter's book value per share.
