FUND OVERVIEW

The Fund is a sub fund of iShares III plc and aims to deliver a return through a combination of capital growth and income by tracking the performance of the MSCI Europe Small Cap Index, its benchmark index.

KEY BENEFITS

1. Is passively managed and aims to invest, as far as possible and practicable, in equity securities (shares) that make up the MSCI Europe Small Cap Index.
2. The Index tracks the performance of small capitalisation stocks across developed European markets and is free float adjusted and market capitalisation weighted, meaning it includes only shares readily available to investors
3. Uses optimising techniques to achieve a similar return to the Index. This may include the strategic selection of certain securities that make up the Index.

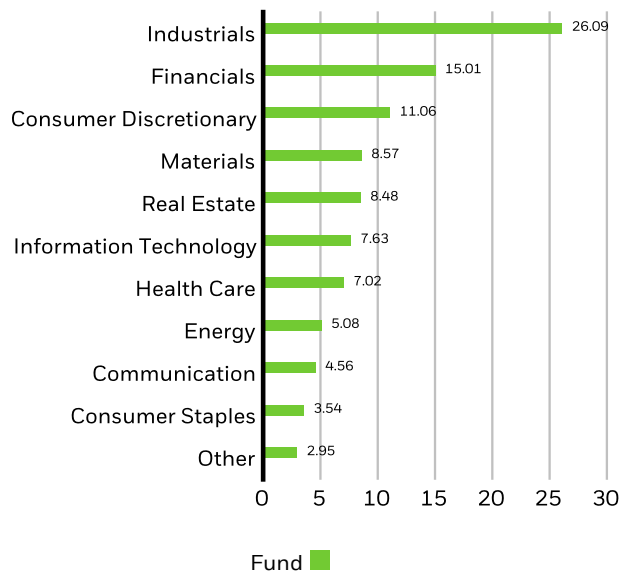

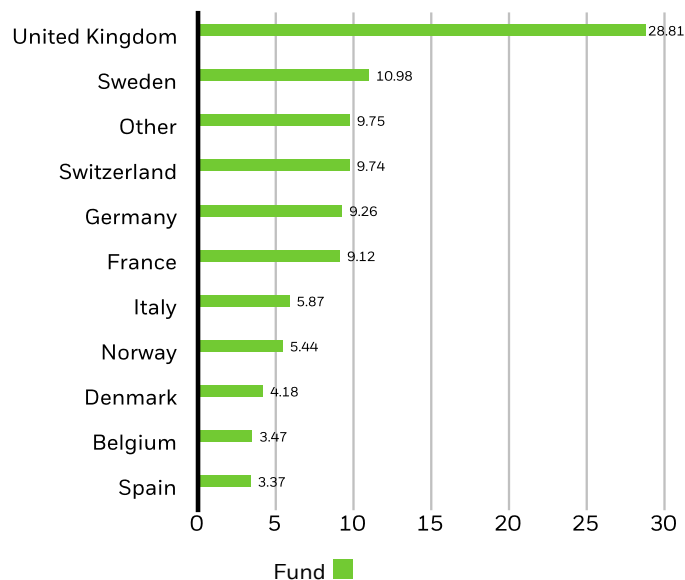
