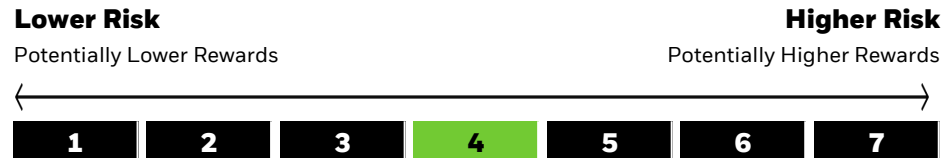
FUND OVERVIEW

The Fund is a sub-fund of iShares III plc and aims to deliver a return through a combination of capital growth and income by tracking the performance of the MSCI Europe Small Cap Index, its benchmark index.

KEY BENEFITS

- 1. Is passively managed and aims to invest, as far as possible and practicable, in equity securities (shares) that make up the MSCI Europe Small Cap Index.
- 2. The Index tracks the performance of small-capitalisation stocks across developed European markets and is free float-adjusted and market capitalisation-weighted, meaning it includes only shares readily available to investors
- 3. Uses optimising techniques to achieve a similar return to the Index. This may include the strategic selection of certain securities that make up the Index.

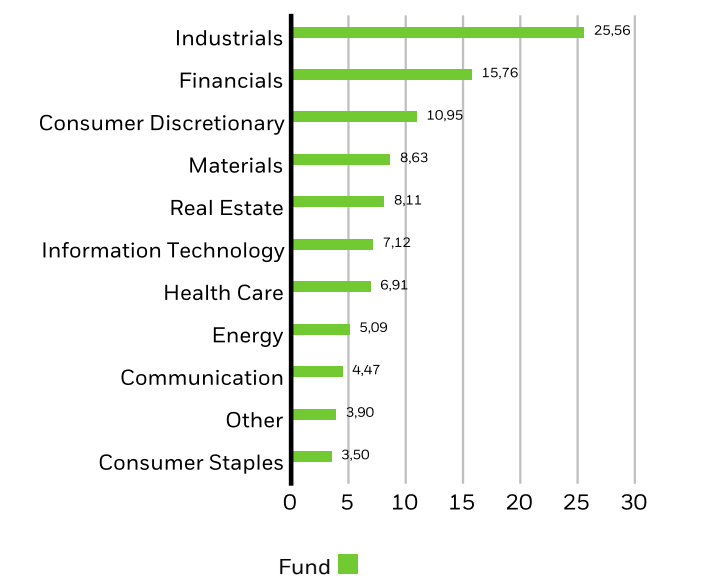

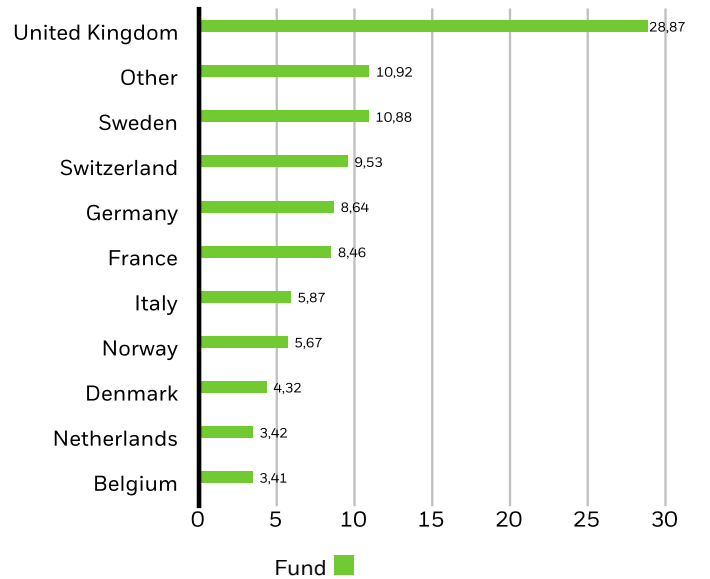
