FUND OVERVIEW

The Fund aims to achieve a return on your investment through a combination of capital growth and income by tracking the performance of the STOXX Europe 600 Foreign Focus Index.

KEY BENEFITS

1. The Index excludes companies that generate 50% or more of their revenues domestically within the STOXX Europe 600 Developed Markets region. The remaining companies form the Index. At each rebalance, companies newly entering the investment universe are subject to this 50% exclusion threshold, while companies already in the universe but not included in the Index are only added if their foreign revenue exposure exceeds 55%.
2. The Index is free float adjusted and market capitalisation weighted and is rebalanced on a quarterly basis.
3. The Fund seeks to replicate the Index by directly holding the equity securities that make up the Index in similar proportions

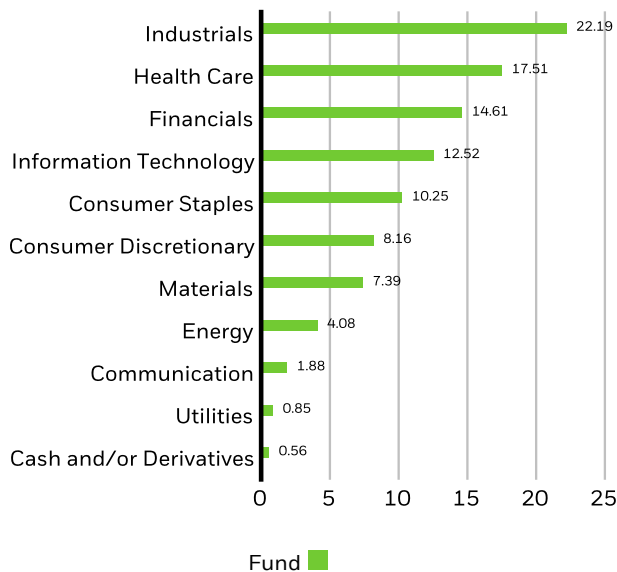

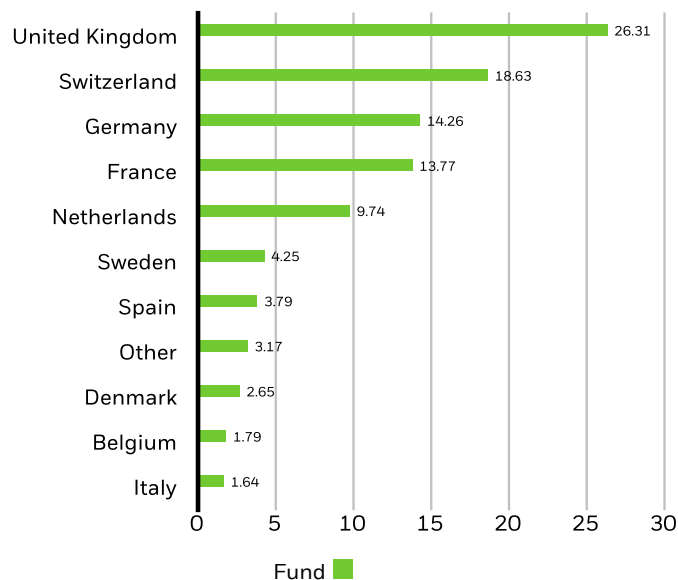
