## FUND OVERVIEW

The Fund seeks to generate a return on your investment that reflects the return of the Bloomberg MSCI December 2037 Maturity EUR Corporate ESG Screened Index (the Fund's benchmark index) through a combination of capital growth and returns on the Fund's assets.

## KEY BENEFITS

1. Provides exposure to investment grade, taxable fixed income, euro-denominated corporate bonds maturing between 01/01/2037 and 02/12/2037
2. With regard to investments in the Fund, it is stipulated that the shares held by shareholders as of 02.12.2037 will be redeemed on 03.12.2037 without further notice or consent of the shareholders
3. The index applies filters to exclude issuers associated with the following business segments/activities: tobacco, nuclear weapons, civilian firearms, controversial weapons, thermal coal extraction, thermal coal power generation, oil sands, conventional weapons, and weapons systems/components/support systems/services.

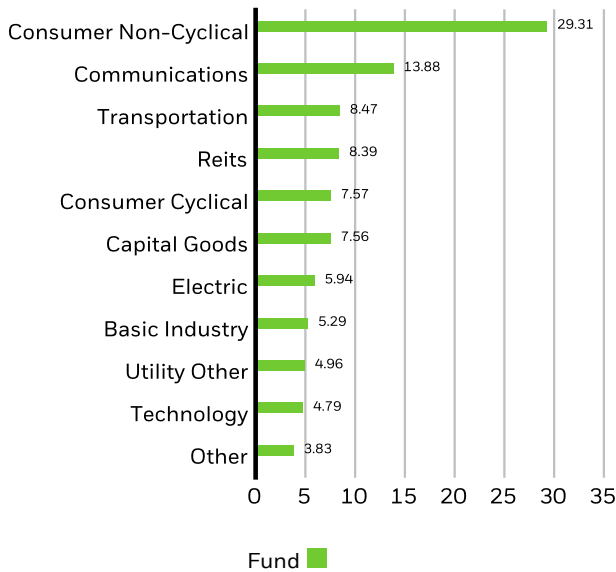

## SECTOR BREAKDOWN (%)



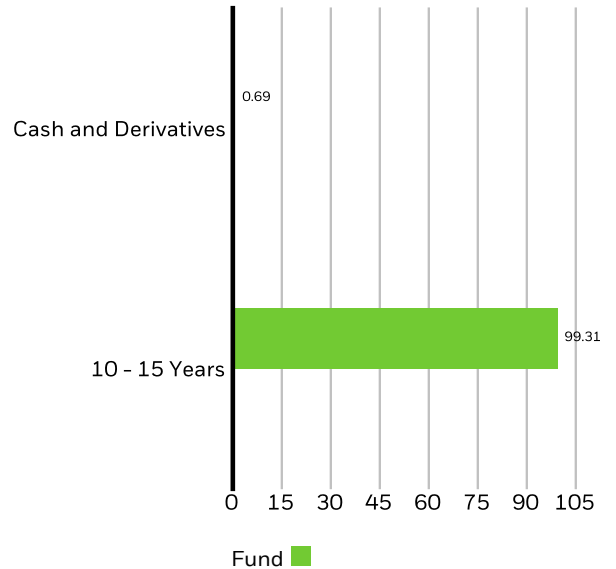

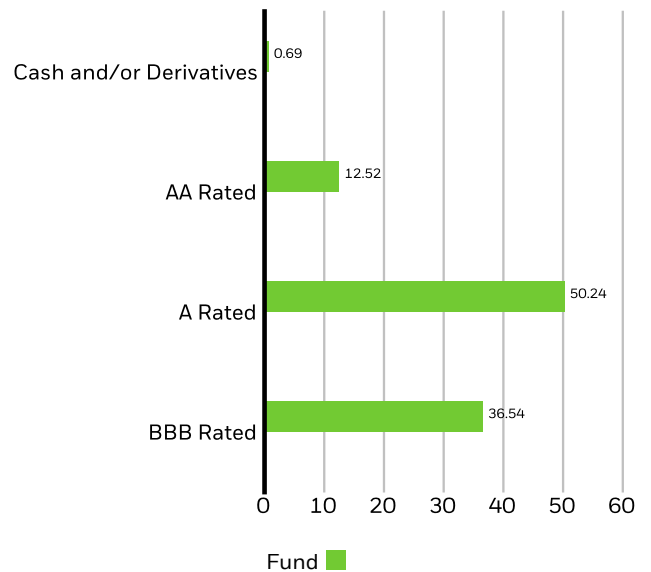

## GLOSSARY

**Yield to Maturity:** Yield to Maturity (YTM) is the discount rate that equates the present value of bond's cash flows with its market price (including accrued interest). The fund YTM is the weighted average of fund's individual bond holding YTM's based upon Net Asset Value ("NAV"). The measure does not include fees and expenses. For callable bonds, YTM is the Yield-to-Worst.

**Effective Duration:** Effective duration is a measure of a fund's interest-rate sensitivity. Put simply, the longer a fund's duration, the more sensitive the fund is to shifts in interest rates. So a fund with a duration of 10 years is twice as volatile as a fund with a five-year duration.
