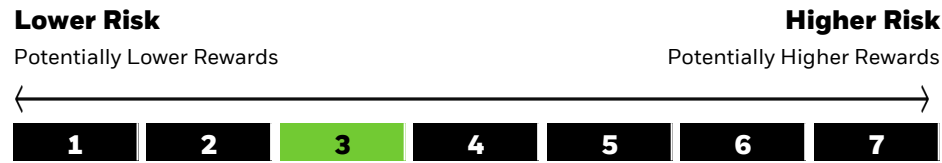
FUND OVERVIEW

The fund aims to achieve a return on your investment, through a combination of capital growth and income on the Fund's assets, which reflects the return of the Bloomberg MSCI December 2033 Maturity USD Corporate ESG Screened Index, the Fund's benchmark index

- 1. Provides exposure to investment grade, taxable fixed rate, US Dollar denominated corporate bonds which mature between 01/01/2033 and 02/12/2033
- 2. It is a term of investment in the Fund that Shareholders on 02/12/2033 will have their Shares redeemed without further notice or Shareholder approval on 03/12/2033
- 3. The Index applies screens which exclude issuers that are involved in the following business lines/activities: tobacco, nuclear weapons, civilian firearms, controversial weapons, thermal coal mining, generation of thermal coal power, oil sands, conventional weapons and weapons systems/components/support systems/services.

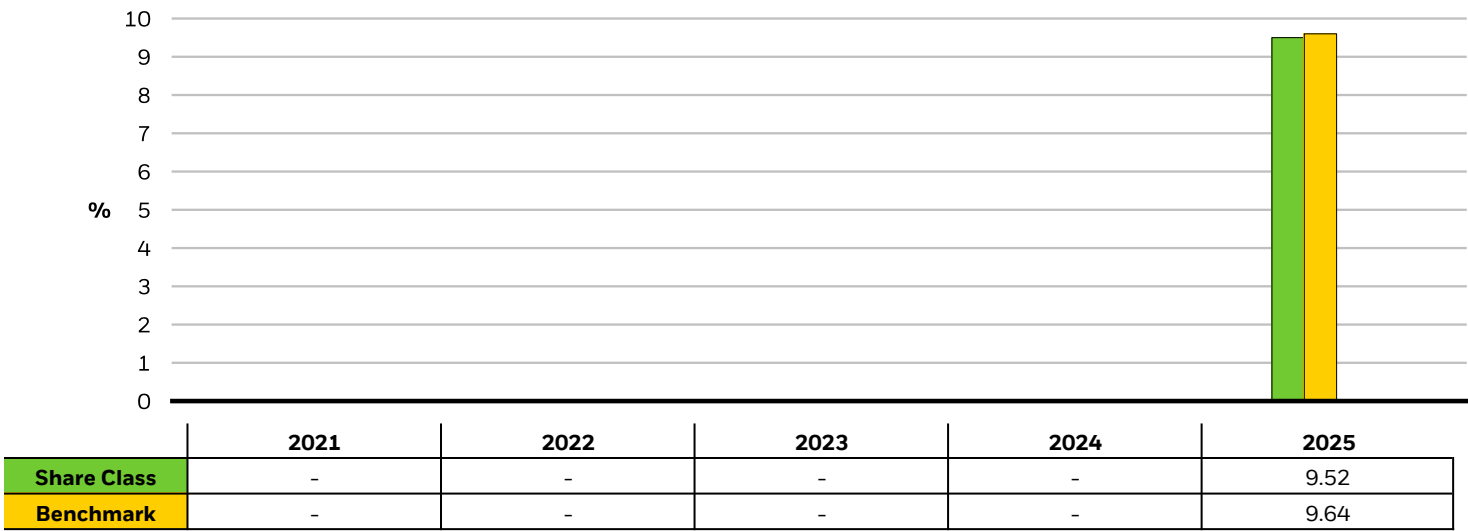

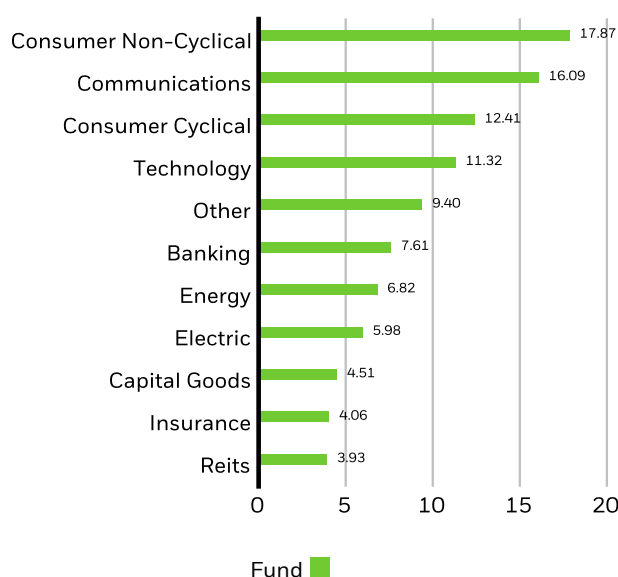

SECTOR BREAKDOWN (%)



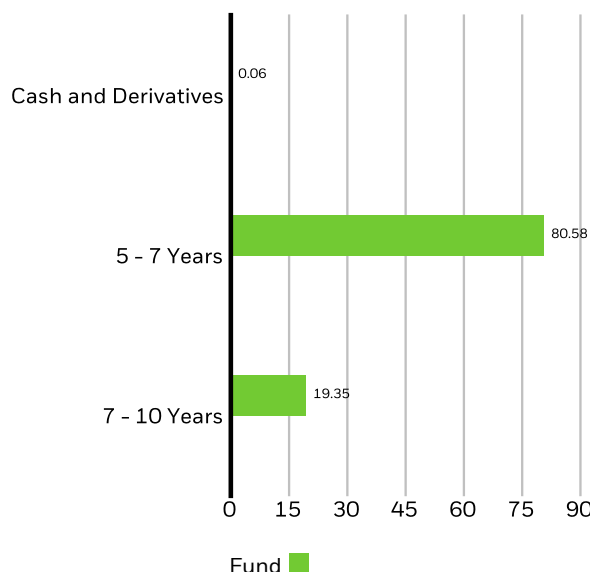

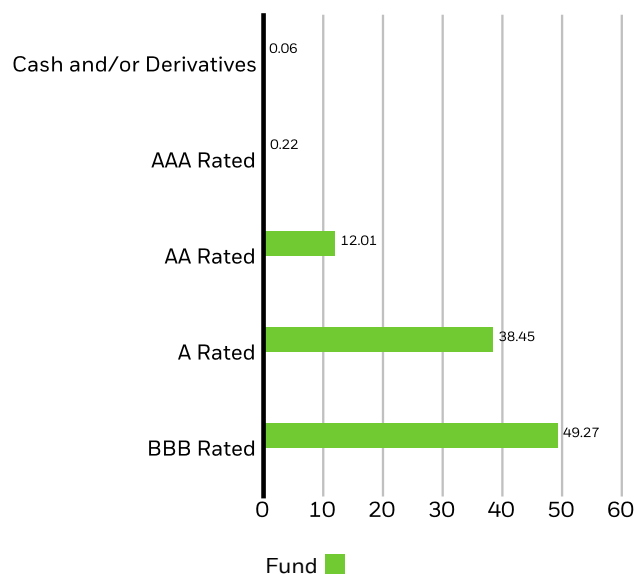

GLOSSARY

Yield to Maturity: Yield to Maturity (YTM) is the discount rate that equates the present value of bond's cash flows with its market price (including accrued interest). The fund YTM is the weighted average of fund's individual bond holding YTM's based upon Net Asset Value ('NAV'). The measure does not include fees and expenses. For callable bonds, YTM is the Yield-to-Worst.

Effective Duration: Effective duration is a measure of a fund's interest-rate sensitivity. Put simply, the longer a fund's duration, the more sensitive the fund is to shifts in interest rates. So a fund with a duration of 10 years is twice as volatile as a fund with a five-year duration.
