FUND OVERVIEW

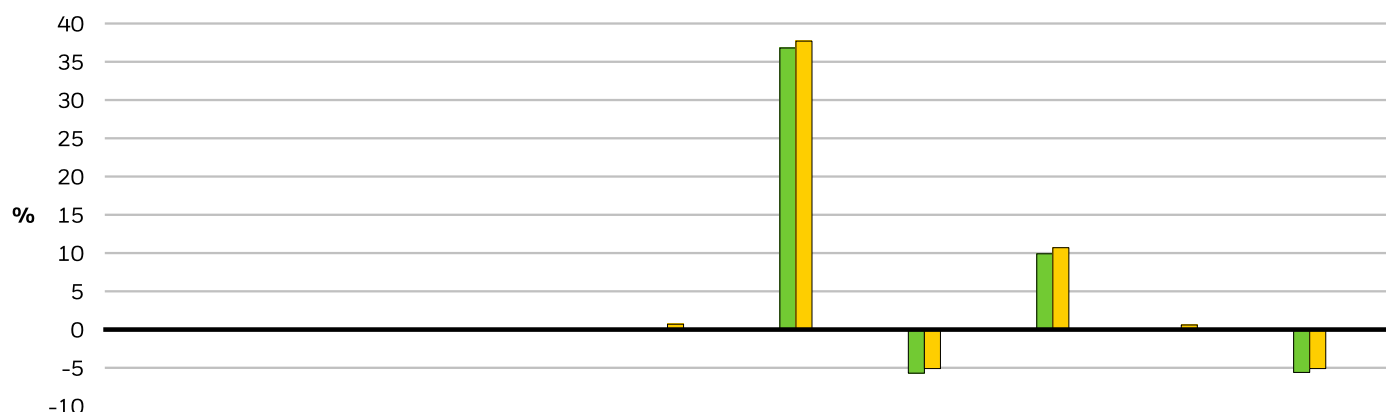

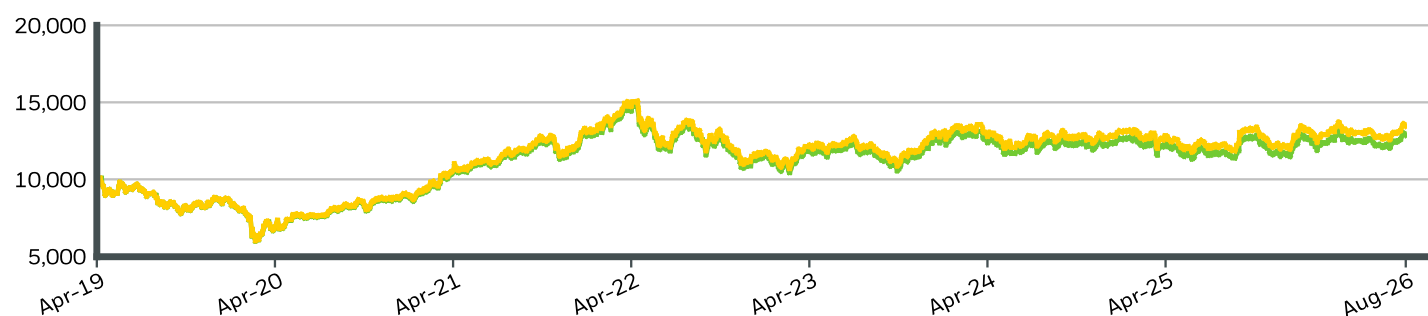

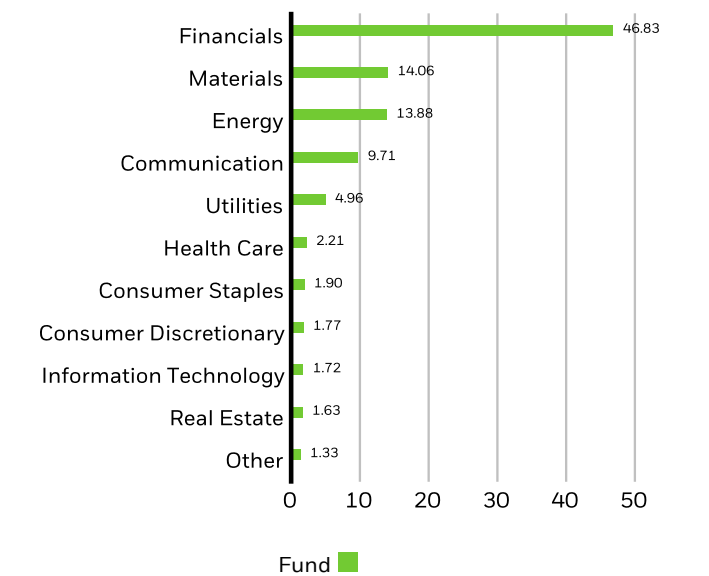
