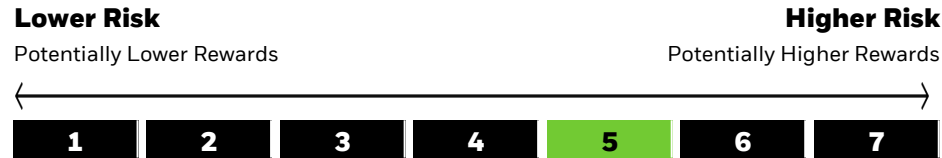
FUND OVERVIEW

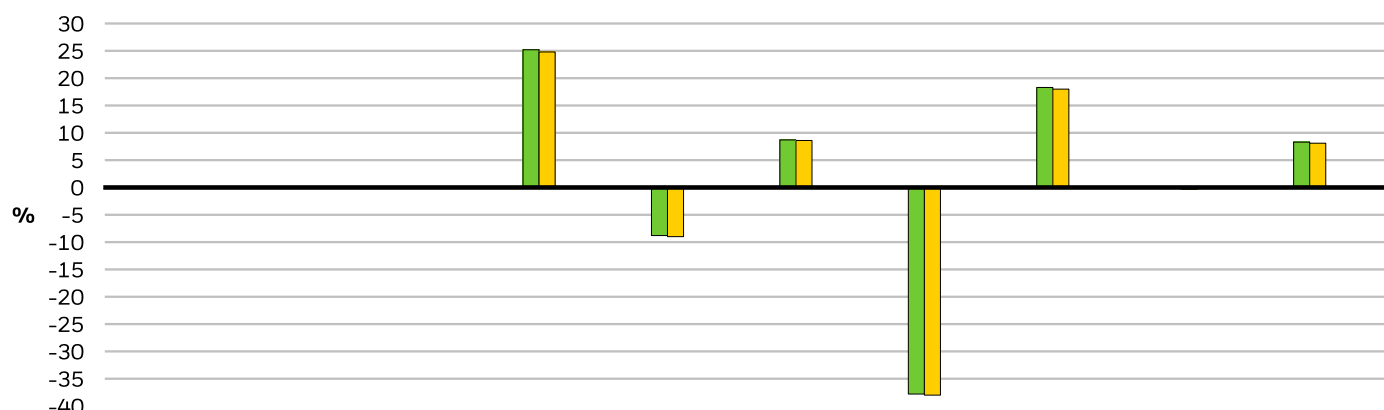

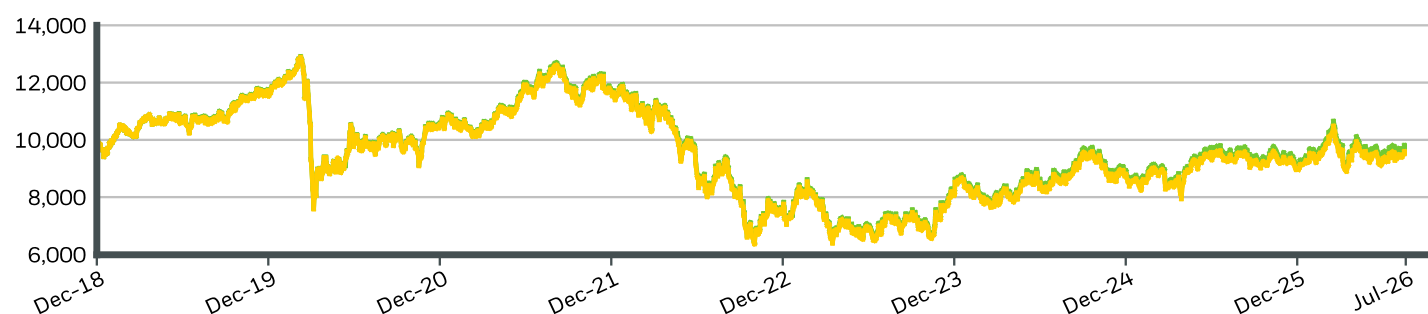

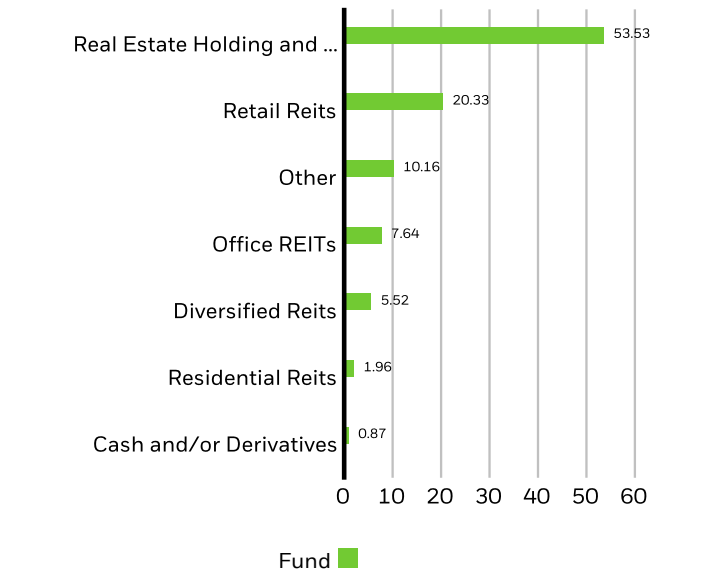

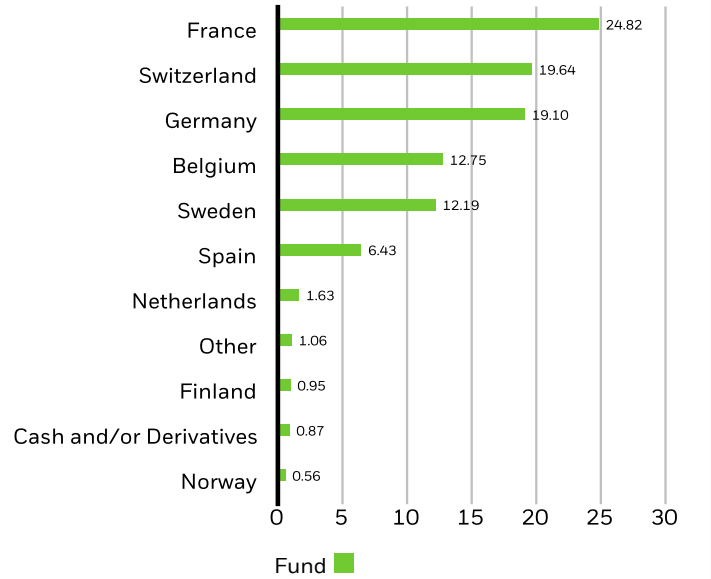
