FUND OVERVIEW

- The Fund aims to achieve a return on your investment, through a combination of capital growth and income on the Fund's assets, which reflects the return of the equity market in the European Economic and Monetary Union (EMU).
- The Fund is passively managed and invests so far as possible and practicable in equity securities (e.g. shares) that make up the MSCI EMU Index, the Fund's benchmark index.
- The benchmark index measures the performance of the equity market within the EMU and is a free float-adjusted market capitalisation weighted index. Free floatadjusted means that only shares readily available in the market rather than all of a company's issued shares are used in calculating the benchmark index. Free floatadjusted market capitalisation is the share price of a company multiplied by the number of shares readily available in the market. As at the end of November 2018, the benchmark index consists of the following 10 developed market country indices: Austria, Belgium, Finland, France, Germany, Ireland, Italy, the Netherlands, Portugal, and Spain.

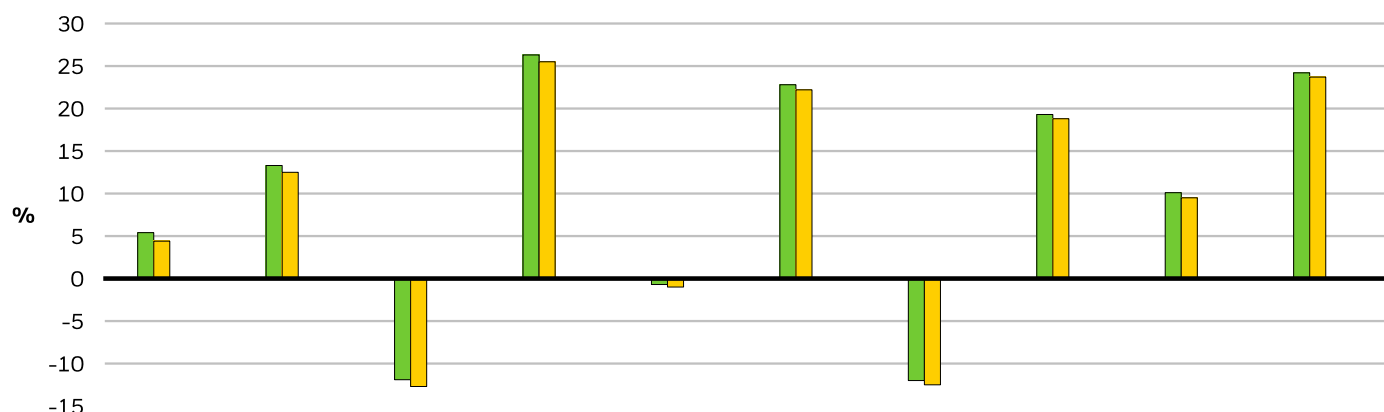

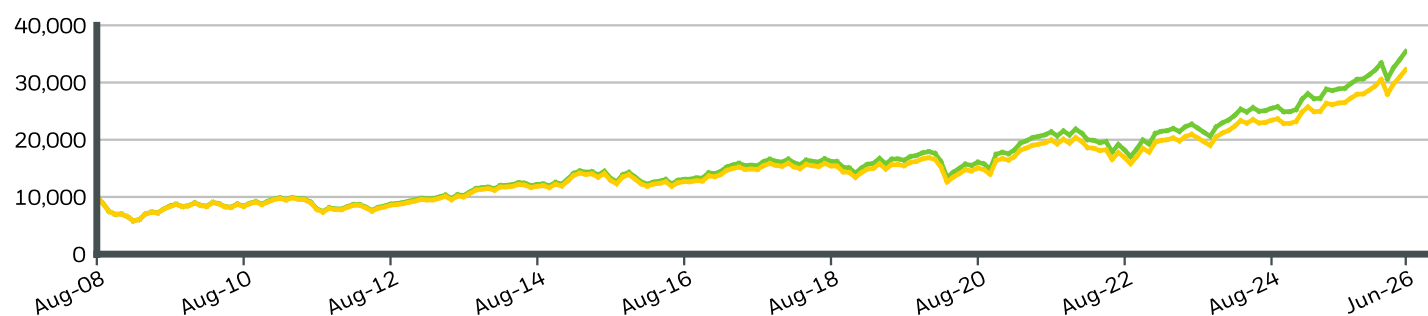

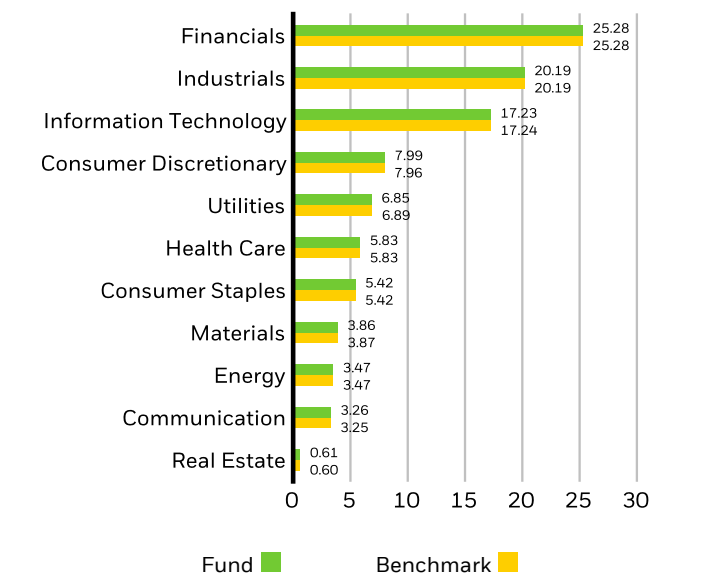

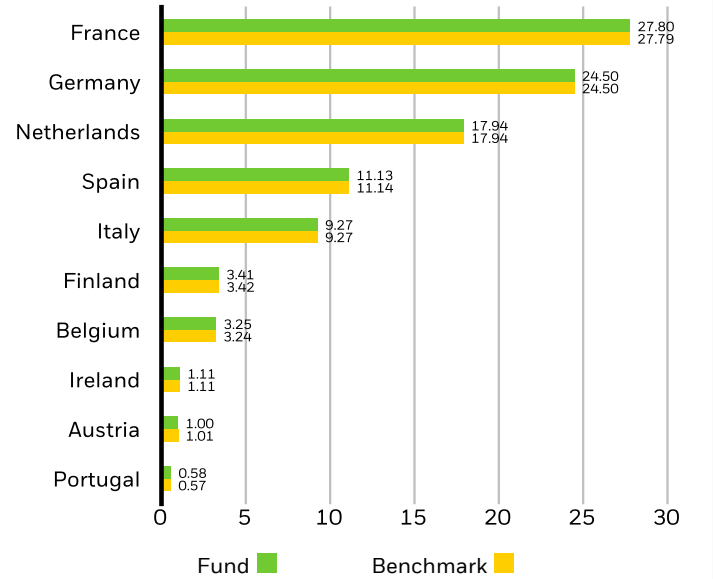
