FUND OVERVIEW

The aims to achieve a return on your investment through a combination of capital growth and income on the Fund's assets, which reflects the return of the Bloomberg MSCI December 2028 Maturity USD Corporate High Yield Custom ESG Screened Index, the Fund's benchmark index (Index).

KEY BENEFITS

- 1. Provides exposure to fixed rate USD denominated corporate bonds maturing between 01/01/2028 and 02/12/2028. The Index is comprised of high yield bonds until approximately 16 months prior to the Index's final maturity date. After that point, the Index will become a composite index, comprised of sub-indices of high yield and investment grade bonds maturing in the final year of maturity
- 2. With regard to investments in the fund, it is stipulated that the shares held by shareholders as of 02.12.2028 will be redeemed on 03.12.2028 without further notice or consent of the unitholders.
- 3. The Index applies screens which exclude issuers that are involved in the following business lines/activities: tobacco, nuclear weapons, civilian firearms, controversial weapons, thermal coal (including thermal coal mining and power generation), oil sands, conventional weapons and weapons systems/components/support systems/services.

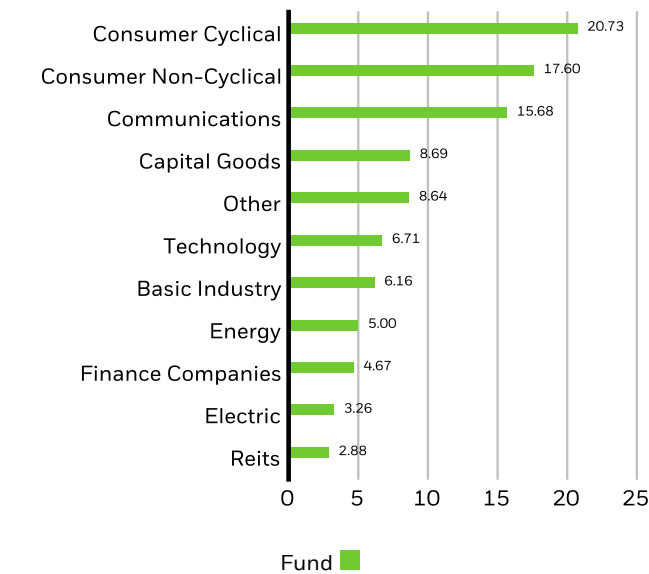

SECTOR BREAKDOWN (%)



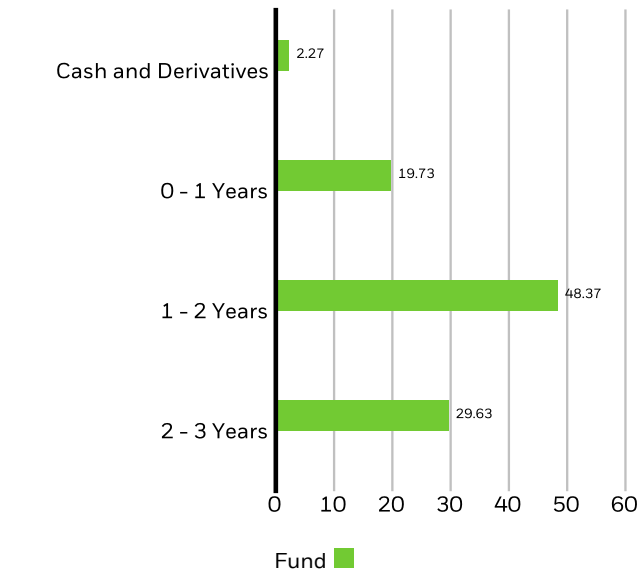

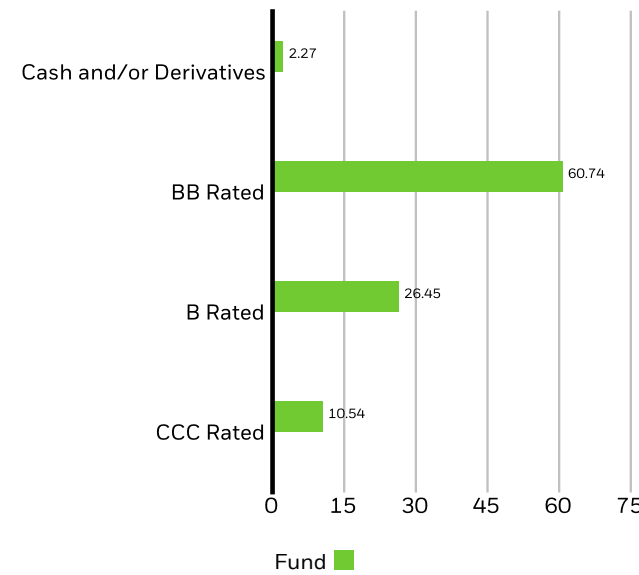

GLOSSARY

Yield to Maturity: Yield to Maturity (YTM) is the discount rate that equates the present value of bond's cash flows with its market price (including accrued interest). The fund YTM is the weighted average of fund's individual bond holding YTM's based upon Net Asset Value ('NAV'). The measure does not include fees and expenses. For callable bonds, YTM is the Yield-to-Worst.

Effective Duration: Effective duration is a measure of a fund's interest-rate sensitivity. Put simply, the longer a fund's duration, the more sensitive the fund is to shifts in interest rates. So a fund with a duration of 10 years is twice as volatile as a fund with a five-year duration.
