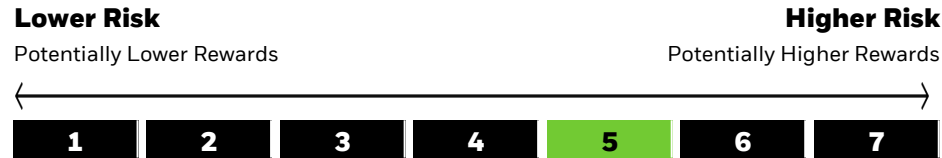
FUND OVERVIEW

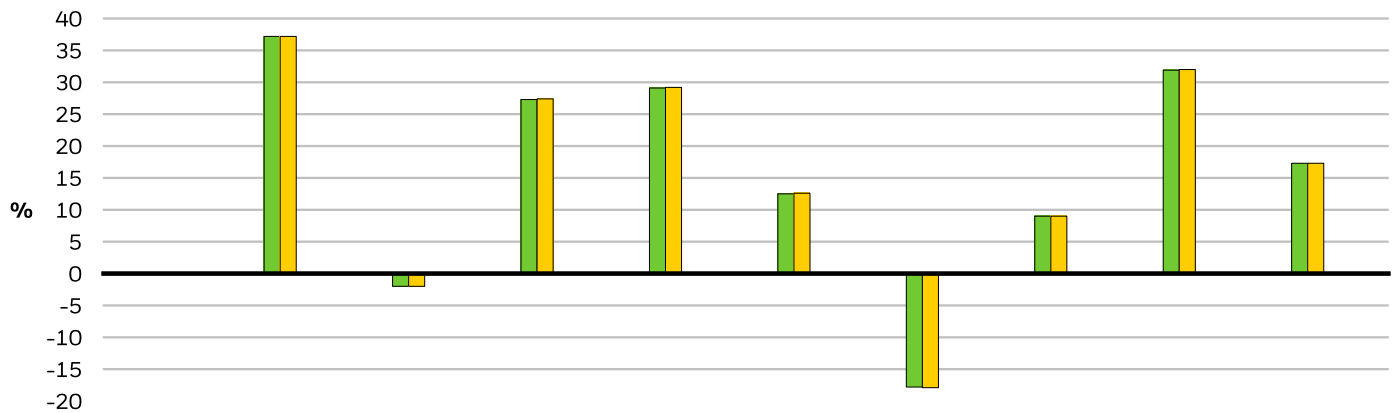

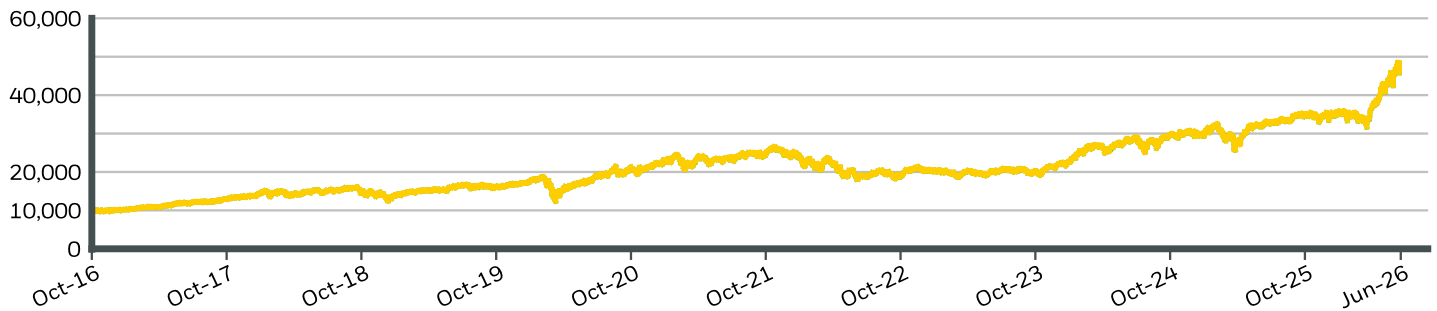

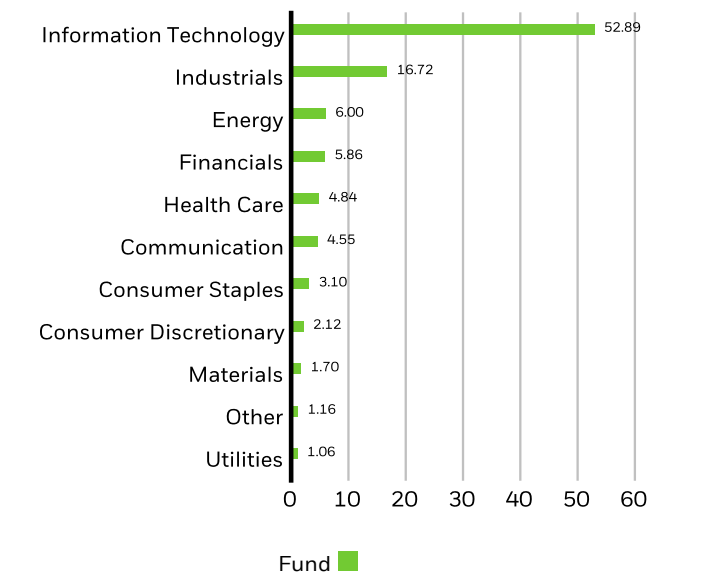
