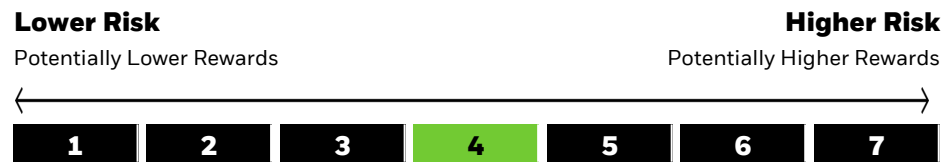
FUND OVERVIEW

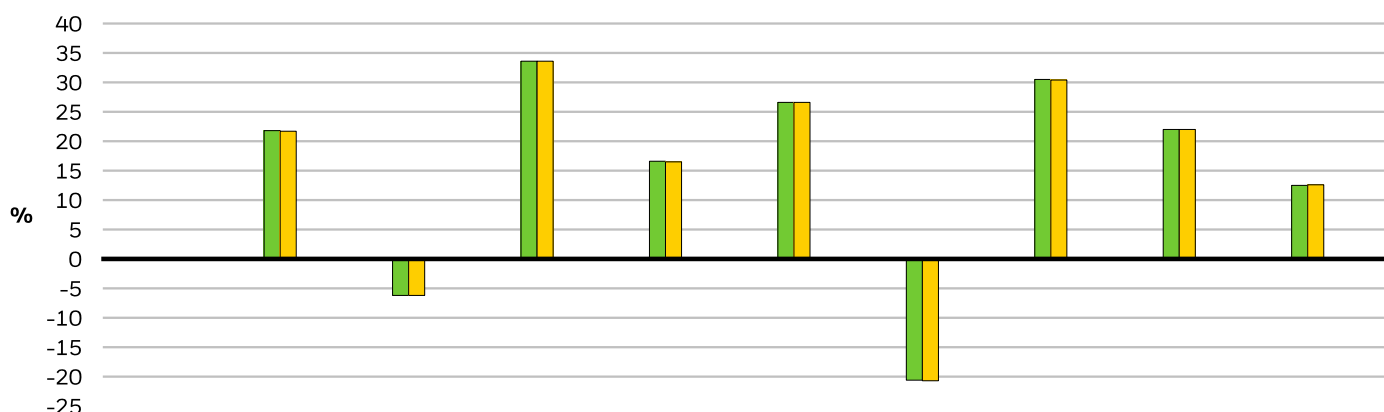

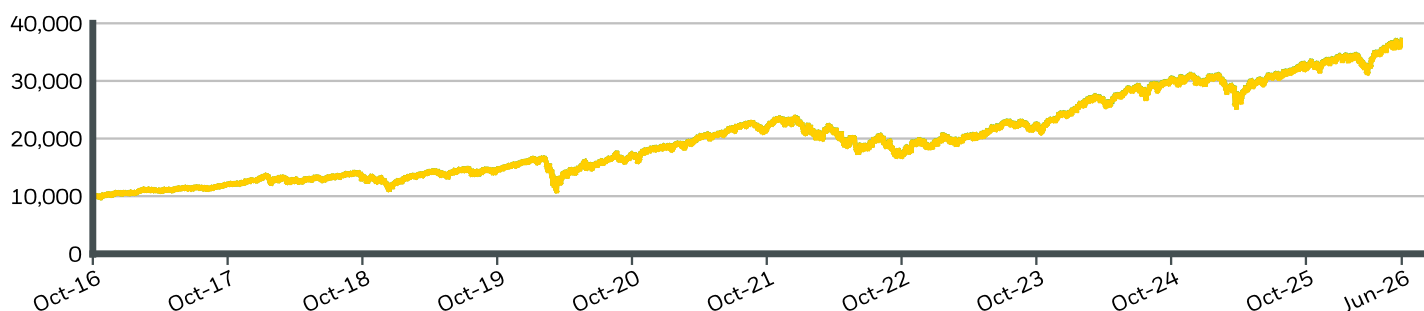

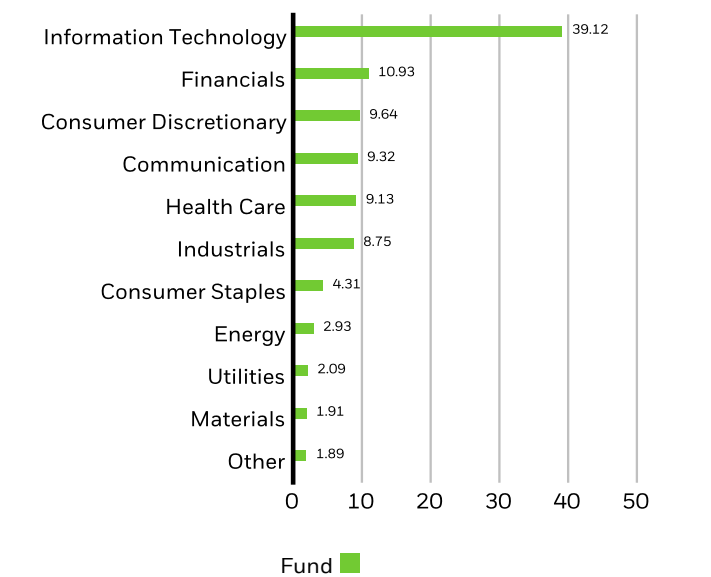
