

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

BGF Global Unconstrained Equity Fund (the “Fund”), **Class X2 USD** (the “Share Class”), ISIN: **LU2720917223**, is authorised in Luxembourg and manufactured by BlackRock (Luxembourg) S.A. (the “Manager”) which is part of the BlackRock, Inc group.

The Manager is authorised in Luxembourg and regulated by the Commission de Surveillance du Secteur Financier (the “CSSF”) and the CSSF is responsible for supervising the Manager in relation to this Key Information Document.

What is this product?

Type: The Fund is a sub-fund of BlackRock Global Funds, an umbrella company incorporated in Luxembourg, authorised by the Commission de Surveillance du Secteur Financier as a Undertaking for Collective Investment in Transferable Securities (“UCITS”).

Term: The Fund does not have a fixed term of existence or maturity period but in certain circumstances, as described in the Fund prospectus, the Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

Objectives

- The Fund seeks to achieve long term capital growth.
- The Fund invests at least 80% of its total assets in the equity securities and equity-related securities (namely American Depositary Receipts (ADRs) and Global Depositary Receipts (GDRs)) of companies domiciled in, or exercising a significant part of their economic activity in global developed markets.
- Investment decisions are based on company-specific research to identify and select equity securities that, in the opinion of the Investment Adviser (IA), have viable competitive advantage and the potential to produce attractive long-term capital growth. The Fund’s portfolio is expected to be concentrated (i.e. expected to hold few stocks in comparison to other funds), but there is no guarantee that this will always be the case.
- The Fund will take into account the principles of environmental, social and governance (“ESG”) criteria in its investments selection as detailed in the prospectus. For further details, please refer to the prospectus and the BlackRock’s website at <https://www.blackrock.com/baselinescreens>.
- Although most of the Fund’s investments will be in companies located in developed markets globally, the Fund may also invest in emerging markets and namely in: equity securities and equity-related securities (ADRs and GDRs) of companies domiciled in, or exercising a significant part of their economic activity in, global emerging markets; cash and/or cash equivalents, liquid government debt instruments and Money Markets Instruments; and other collective investment schemes (CIS) including exchange-traded funds (where the objectives of such CIS are consistent with its objective or for efficiently managing cash holdings and/or collateral).
- The IA may use derivatives for the purposes of efficient portfolio management.
- The Fund is actively managed, and the IA has discretion to select the Fund’s investments.
- The price of equity securities fluctuates daily and may be influenced by factors affecting the performance of the individual companies issuing the equities, as well as by daily stock market movements, and broader economic and political developments which in turn may affect the value of your investment.
- The return on your investment in the Fund is directly related to the value of the underlying assets of the Fund, less costs (see “What are the costs?” below).
- The relationship between the return on your investment, how it is impacted and the period for which you hold your investment is considered below (see “How long should I hold it and can I take my money out early?”).
- The depositary of the Fund is The Bank of New York Mellon SA/NV, Luxembourg Branch.

- Your shares will be non-distributing (i.e. dividend income will be included in their value).
- Your shares will be denominated in US Dollar, the Fund’s base currency.
- You can buy and sell your shares daily. The minimum initial investment for this share class is US\$10,000 or other currency equivalent.

Intended retail investor: This Fund is intended for retail investors (i) with knowledge and/or experience of these types of products, (ii) that have obtained appropriate investment advice and (iii) that have the ability to bear losses up to the amount they have invested in the Fund (see “How long should I hold it and can I take my money out early?”).

What happens if BlackRock (Luxembourg) S.A. is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary, The Bank of New York Mellon SA / NV, Luxembourg Branch (the "Depositary"). In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations). As a shareholder of the Fund you would not be able to make a claim to the UK Financial Services Compensation Scheme or any other scheme about the Fund in the event that the Fund is unable to pay out.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time: The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does.
