

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

Sukuk Fund (the "Fund"), **Class D2 USD** (the "Share Class"), ISIN: **LU3364741754**, is authorised in Luxembourg and manufactured by BlackRock (Luxembourg) S.A. (the "Manager") which is part of the BlackRock, Inc group.

The Manager is authorised in Luxembourg and regulated by the Commission de Surveillance du Secteur Financier (the "CSSF") and the CSSF is responsible for supervising the Manager in relation to this Key Information Document.

What is this product?

Type: The Fund is a sub-fund of BlackRock Global Funds, an umbrella company incorporated in Luxembourg, authorised by the Commission de Surveillance du Secteur Financier as a Undertaking for Collective Investment in Transferable Securities ("UCITS").

Term: The Fund does not have a fixed term of existence or maturity period but in certain circumstances, as described in the Fund prospectus, the Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

Objectives

- The Fund seeks to maximise total return through a combination of income and capital growth in line with Shari'ah investment principles.
- The Fund will invest at least 70% of its total assets in USD denominated investment grade sukuk issued by sovereign, quasi sovereign, corporate and supranational entities. The securities include issuers labelled as Sukuk and compliant with the AAOIFI standards.
- All securities selected by the Investment Adviser are screened by IdealRatings and are deemed compliant with the Shari'ah principles, as further detailed in section "Investments in a Shari'ah Fund" in the prospectus.
- In the rare event that any non-Shari'ah compliant income is nonetheless received by the Fund, such income will be excluded from the Fund's Net Asset Value and donated to approved charities for purification purposes, as further detailed in section "Purification of non-Shari'ah compliant Income" in the prospectus.
- The Fund's exposure to contingent convertible bonds is limited to 10% of its total assets and its exposure to Distressed Securities is limited to 5% of its total assets. Any such investments will be strictly limited to structures that have been reviewed and approved as Shari'ah-compliant by the appointed Shari'ah Panel.
- The Fund is designed for Islamic investors, but subscription is opened to any other investors who is interested in investing in the Fund.
- The Fund is actively managed, and the Investment Adviser (IA) has discretion to select the Fund's investments. In doing so, the IA will refer to the J.P. Morgan USD Aggregate Sukuk IG Index (the "Index") when constructing the Fund's portfolio, and also for risk management purposes to ensure that the active risk (i.e. degree of deviation from the Index) taken by the Fund remains appropriate given the Fund's investment objective and policy. The IA is not bound by the components or weighting of the Index when selecting investments. The IA may also use its discretion to invest in securities not included in the Index in order to take advantage of specific investment opportunities. The Index has been chosen by the IA because it has determined that it is representative of the investment universe of the Fund and should be used by investors to compare the performance of the Fund.
- The IA may use Shari'ah-compliant financial derivative instruments (FDIs) (i.e. investments the prices of which are based on one or more underlying assets) for investment purposes (not speculation) in order to achieve the investment objective of the Fund, or efficient portfolio management purposes.
- The price of Sukuk may be affected by changes in interest rates, which in turn may affect the value of your investment. Sukuk prices generally move inversely to interest rates. Therefore, the market value of Sukuk and other fixed income securities may decrease as interest rates increase. The credit rating of an issuing entity will generally affect the yield that can be earned on Sukuk and other fixed income securities; generally the better the credit rating, the lower the yield. The price of a derivative changes on a daily basis depending on the value of the underlying reference asset(s) which in turn may affect the value of your investment.
- The return on your investment in the Fund is directly related to the value of the underlying assets of the Fund, less costs (see "What are the costs?" below).
- The relationship between the return on your investment, how it is impacted and the period for which you hold your investment is considered below (see "How long should I hold it and can I take my money out early?").
- The depositary of the Fund is The Bank of New York Mellon SA/NV, Luxembourg Branch.

- Your shares will be non-distributing (i.e. dividend income will be included in their value).
- Your shares will be denominated in US Dollar, the Fund's base currency.
- You can buy and sell your shares daily. The minimum initial investment for this share class is US\$100,000 or other currency equivalent.

Intended retail investor: The Fund is intended for retail investors with the ability to bear losses up to the amount invested in the Fund (see "How long should I hold it and can I take my money out early?").

Insurance benefits: The Fund does not offer any insurance benefits.

What happens if BlackRock (Luxembourg) S.A. is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary, The Bank of New York Mellon SA / NV, Luxembourg Branch (the "Depositary"). In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations). As a shareholder of the Fund you would not be able to make a claim to the UK Financial Services Compensation Scheme or any other scheme about the Fund in the event that the Fund is unable to pay out.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time: The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return).
- For the other holding periods we have assumed the product performs as shown in the moderate scenario.
