

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

World Islamic Gold Fund (the "Fund"), **Class X2 USD** (the "Share Class"), ISIN: **LU3424463886**, is authorised in Luxembourg and manufactured by BlackRock (Luxembourg) S.A. (the "Manager") which is part of the BlackRock, Inc group.

The Manager is authorised in Luxembourg and regulated by the Commission de Surveillance du Secteur Financier (the "CSSF") and the CSSF is responsible for supervising the Manager in relation to this Key Information Document.

What is this product?

Type: The Fund is a sub-fund of BlackRock Global Funds, an umbrella company incorporated in Luxembourg, authorised by the Commission de Surveillance du Secteur Financier as a Undertaking for Collective Investment in Transferable Securities ("UCITS").

Term: The Fund does not have a fixed term of existence or maturity period but in certain circumstances, as described in the Fund prospectus, the Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

Objectives

- The Fund seeks to maximise total returns in line with Shari'ah investment principles.
- The Fund will invest globally at least 70% of its total assets in the equity securities of companies whose predominant economic activity is gold mining. The Fund may also invest in the equity securities of companies whose predominant economic activity is other precious metals or mineral and base metal or mineral mining. The Fund does not hold physical gold or metal.
- The Fund will invest in publicly listed equity securities selected by the Investment Adviser (IA) from an eligible investment universe that has been screened and approved by the Shari'ah Panel prior to such investments, in accordance with Shari'ah principles.
- The Shari'ah Panel, appointed by the IA, will be ascertaining the compliance of the Fund's operations with Shari'ah. All securities selected by the IA are reviewed and reassessed on a quarterly basis by the Shari'ah Panel to confirm if the portfolio holdings remain compliant with the Shari'ah principles as further detailed in section "Investments in a Shari'ah Fund" in the prospectus.
- The Shari'ah Panel will provide monthly dividend purification ratios, which will be applied by the Fund's fund accountant on a daily basis to calculate the pure and impure portions of income, taking into account dividends declared on ex-date. In the event that any impure income is received by the Fund, such income will be segregated and donated to charitable organisations in accordance with the Fund's purification process, as further described in the prospectus.
- The Fund is designed for Islamic investors, but subscription is opened to any other investors who is interested in investing in the Fund.
- The Fund is actively managed, and the IA has discretion to select the Fund's investments. The IA will refer to the NYSE Arca Gold Miners Index (the "Index") when constructing the Fund's portfolio, and also for risk management purposes to ensure that the active risk (i.e. degree of deviation from the Index) taken by the Fund remains appropriate given the Fund's investment objective and policy. The IA is not bound by the components or weighting of the Index when selecting investments. The IA may also use its discretion to invest in securities not included in the Index in order to take advantage of specific investment opportunities. The Index has been chosen by the IA because it has determined that it is representative of the investment universe of the Fund and should be used by investors to compare the performance of the Fund
- The IA may use Shari'ah-compliant financial derivative instruments (FDIs) (i.e. investments the prices of which are based on one or more underlying assets) for investment purposes (not speculation) in order to achieve the investment objective of the Fund, or efficient portfolio management purposes.
- The price of equity securities fluctuates daily and may be influenced by factors affecting the performance of the individual companies issuing the equities, as well as by daily stock market movements, and broader economic and political developments which in turn may affect the value of your investment. The price of a derivative changes on a daily basis depending on the value of the underlying reference asset(s) which in turn may affect the value of your investment.
- The return on your investment in the Fund is directly related to the value of the underlying assets of the Fund, less costs (see "What are the costs?" below).
- The relationship between the return on your investment, how it is impacted and the period for which you hold your investment is considered below (see "How long should I hold it and can I take my money out early?").
- The depositary of the Fund is The Bank of New York Mellon SA/NV, Luxembourg Branch.

- Your shares will be non-distributing (i.e. dividend income will be included in their value).
- Your shares will be denominated in US Dollar, the Fund's base currency.
- You can buy and sell your shares daily. The minimum initial investment for this share class is US\$10,000,000 or other currency equivalent.

Intended retail investor: The Fund is intended for retail investors with the ability to bear losses up to the amount invested in the Fund (see "How long should I hold it and can I take my money out early?").

Insurance benefits: The Fund does not offer any insurance benefits.

What happens if BlackRock (Luxembourg) S.A. is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary, The Bank of New York Mellon SA / NV, Luxembourg Branch (the "Depositary"). In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations). As a shareholder of the Fund you would not be able to make a claim to the UK Financial Services Compensation Scheme or any other scheme about the Fund in the event that the Fund is unable to pay out.

What are the costs?
