Product

BlackRock for Formue North America Equity Index Fund (the "Fund"), **Class F Accu SEK** (the "Share Class"), ISIN: **IE000K68ETC4**, is authorised in Ireland and manufactured by BlackRock Asset Management Ireland Limited (the "Manager") which is part of the BlackRock, Inc group.

The Manager is authorised in Ireland and regulated by the Central Bank of Ireland (the "CBI") and the CBI is responsible for supervising the Manager in relation to this Key Information Document.

What is this product?

Type: The Fund is a sub-fund of BlackRock Solutions Funds ICAV, an Irish collective asset-management vehicle constituted as an umbrella fund in Ireland, authorised by the Central Bank of Ireland as a Undertaking for Collective Investment in Transferable Securities ("UCITS").

Term: The Fund does not have a fixed term of existence or maturity period but in certain circumstances, as described in the Fund prospectus, the Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

Objectives

- The Fund aims to provide a total return, taking into account both capital and income returns, which reflects the total return of the
- The Fund is passively managed and will invest in a portfolio of equity securities that so far as possible and practicable consists of the component securities of the Index. The Index aims to reflect the performance of a sub-set of equity securities within the MSCI North America Index (the "Parent Index") which remains after the index provider has excluded securities using pre-defined ESG screens, as set by the index provider. The Parent Index measures the performance of large and mid-capitalisation stocks of the North American equity market.
- The Fund will also invest in accordance with its Exclusionary Policy as outlined in the Fund's prospectus.
- The Fund uses optimising techniques to achieve a similar return to its Index. These may include the strategic selection of certain securities that make up the Index. The Fund may hold some securities which are not underlying constituents of the Index.
- The Fund may also invest in financial derivative instruments (FDIs) (i.e. investments the prices of which are based on one or more underlying assets) for direct investment purposes and efficient portfolio management (i.e. to reduce risk within the Fund's portfolio, reduce investment costs and generate additional income).
- The Fund's investments will normally be listed or traded on the Regulated Markets as detailed in the prospectus.
- The Fund may also invest in unlisted securities and in other collective investment schemes, including exchange traded funds.
- The return on your investment in the Fund is directly related to the value of the underlying assets of the Fund, less costs (see "What are the costs?" below).
- The price of equity securities fluctuates daily and may be influenced by factors affecting the performance of the individual companies issuing the equities, as well as by daily stock market movements, and broader economic and political developments which in turn may affect the value of your investment.
- The price of a derivative changes on a daily basis depending on the value of the underlying reference asset(s) which in turn may affect the value of your investment. A change in the value of underlying reference assets can have a greater impact on the value of derivatives than if the assets were held directly since derivatives can be more sensitive to changes in the value of underlying reference assets.
- The relationship between the return on your investment, how it is impacted and the period for which you hold your investment is considered below (see "How long should I hold it and can I take my money out early?").
- The depositary of the Fund is Bank of New York, Dublin Branch.

- The Fund's base currency is Norwegian Kroner. Shares for this class are bought and sold in Swedish Krona. The performance of your shares may be affected by this currency difference.
- You can buy and sell your shares daily. The minimum initial investment for this share class is SEK 200,000,000.

Intended retail investor: The Fund is intended for retail investors with the ability to bear losses up to the amount invested in the Fund (see "How long should I hold it and can I take my money out early?").

What happens if BlackRock Asset Management Ireland Limited is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary, The Bank of New York Mellon SA/NV, Dublin Branch (the "Depositary"). In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations). As a shareholder of the Fund you would not be able to make a claim to the UK Financial Services Compensation Scheme or any other scheme about the Fund in the event that the Fund is unable to pay out.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time: The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does.
