

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

BlackRock MyMap Plus Growth Fund (the "Fund"), **Class D2 Hedged PLN** (the "Share Class"), ISIN: **LU2490918716**, is authorised in Luxembourg and manufactured by BlackRock (Luxembourg) S.A. (the "Manager") which is part of the BlackRock, Inc group.

The Manager is authorised in Luxembourg and regulated by the Commission de Surveillance du Secteur Financier (the "CSSF") and the CSSF is responsible for supervising the Manager in relation to this Key Information Document.

What is this product?

Type: The Fund is a sub-fund of BlackRock Strategic Funds, an umbrella company incorporated in Luxembourg, authorised by the Commission de Surveillance du Secteur Financier as a Undertaking for Collective Investment in Transferable Securities ("UCITS").

Term: The Fund does not have a fixed term of existence or maturity period but in certain circumstances, as described in the Fund prospectus, the Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

Objectives

- The Fund seeks to provide a return on your investment taking into account both capital and income returns through an actively managed, multi-asset portfolio, integrating strategic and tactical asset allocation whilst targeting a growth risk profile and invests in a manner consistent with the principles of environmental, social and governance (ESG) investing.
- The Fund will seek to obtain indirect exposure to a broad range of asset classes, which may include equity securities (e.g. shares), equity-related (ER) securities, fixed income (FI) securities (such as bonds), FI-related securities, alternative assets, cash and near-cash instruments. FI securities include money market instruments (MMIs) (i.e. debt securities with short- term maturities). ER securities and FI-related securities include financial derivative instruments (FDIs) (i.e. investments the prices of which are based on one or more underlying assets). Exposure to these asset classes will be achieved through investments in shares or units of a concentrated portfolio of collective investment schemes (CIS) which invest in a diversified portfolio of assets. These may include, but are not limited to, active and passive exchanged traded funds and other Index funds managed by an affiliate of the BlackRock group.
- The Fund's total assets will be invested according to its ESG policy as described in the prospectus.
- Given the growth risk profile of the Fund, the Fund will seek a higher exposure to equity securities compared to a fund with a lower risk profile, which would normally seek to have a higher exposure to FI securities. The FI exposure of the Fund will comprise mainly investment grade rated (but may also comprise non-investment grade or unrated) fixed and floating rate global government and corporate fixed income securities/bonds.
- The Fund's direct and indirect exposure to non-investment grade FI securities will not exceed 20% of its Net Asset Value (NAV). The equity exposure will comprise mainly large and mid-capitalization companies globally. The Fund's direct and indirect exposure to equities will vary over time but will not exceed 90% of its NAV.
- The Fund may have direct and indirect exposure of up to 20% of its NAV in asset-backed securities and mortgage -backed securities and the Fund's indirect exposure to distressed securities may not exceed 10% of the NAV.
- The Fund is actively managed, and the investment adviser (IA) has discretion to select the Fund's investments and is not constrained by any benchmark in this process. Shareholders may use the MSCI All Country World Index and Bloomberg Multiverse Index to measure the Fund's performance against its ESG commitments. The Fund's asset allocation and the weight of each asset class index in the investable universe may change over time. Shareholders may contact the IA for details and weights of the indices used.
- The price of underlying funds changes regularly depending on the performance of the assets held by the underlying funds which in turn may affect the value of your investment.
- The Fund invests in FI securities, equity securities and collective investment schemes and so the value of your investment may be affected by the factors which impact the value of those asset classes.
- The return on your investment in the Fund is directly related to the value of the underlying assets of the Fund, less costs (see "What are the costs?" below).
- The relationship between the return on your investment, how it is impacted and the period for which you hold your investment is considered below (see "How long should I hold it and can I take my money out early?").
- The depositary of the Fund is State Street Bank International GmbH, Luxembourg Branch.

- Your shares will be non-distributing (i.e. dividend income will be included in their value).
- The Fund's base currency is Euro. Shares for this class are bought and sold in Polish Zloty. The performance of your shares may be affected by this currency difference.
- Your shares will be hedged with the aim of reducing the effect of exchange rate fluctuations between the denominated currency of the shares and the Fund's underlying portfolio currencies or the Fund's base currency. FDIs, including FX forward contracts, will be used for currency hedging purposes. The hedging strategy may not completely eliminate currency risk and, therefore, may affect the performance of your shares. Please see the prospectus for further details.
- You can buy and sell your shares daily. The minimum initial investment for this share class is US\$100,000 or other currency equivalent.

Intended retail investor: The Fund is intended for retail investors with the ability to bear losses up to the amount invested in the Fund (see "How long should I hold it and can I take my money out early?").

Insurance benefits: The Fund does not offer any insurance benefits.

What happens if BlackRock (Luxembourg) S.A. is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary, State Street Bank International GmbH, Luxembourg Branch (the "Depositary"). In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations). As a shareholder of the Fund you would not be able to make a claim to the UK Financial Services Compensation Scheme or any other scheme about the Fund in the event that the Fund is unable to pay out.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time: The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return).
- For the other holding periods we have assumed the product performs as shown in the moderate scenario.
- PLN 40,000 is invested.
