

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

BlackRock Tactical Opportunities Plus Fund (the "Fund"), **Class Z2 USD** (the "Share Class"), ISIN: **LU3296962940**, is authorised in Luxembourg and manufactured by BlackRock (Luxembourg) S.A. (the "Manager") which is part of the BlackRock, Inc group.

The Manager is authorised in Luxembourg and regulated by the Commission de Surveillance du Secteur Financier (the "CSSF") and the CSSF is responsible for supervising the Manager in relation to this Key Information Document.

What is this product?

Type: The Fund is a sub-fund of BlackRock Strategic Funds, an umbrella company incorporated in Luxembourg, authorised by the Commission de Surveillance du Secteur Financier as a Undertaking for Collective Investment in Transferable Securities ("UCITS").

Term: The Fund does not have a fixed term of existence or maturity period but in certain circumstances, as described in the Fund prospectus, the Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

Objectives

- The Fund seeks to achieve a positive absolute return through a combination of capital growth and income regardless of market conditions, and to invest in a manner consistent with the principles of environmental, social, and governance "ESG" focused investing.
- The Fund seeks to achieve its objective with a tactical, macro investment approach by investing globally in equity securities, fixed income securities (FIS) (which may include up to 50% of high yield FIS), instruments relating to such securities (including total return swaps, credit default swaps, interest rate swaps, currency swaps, options, futures, options on futures and forwards), shares or units of CIS (including exchange-traded funds), Money Market Instruments, deposits, foreign currencies and cash, along with any other securities.
- The Fund's total assets will be invested in accordance with its ESG policy. For further details, please refer to the prospectus and the BlackRock website at www.blackrock.com/baselinescreens.
- The Fund will not have a geographical or sector focus but may have a high allocation to particular countries or sectors at any one time. The Fund may have exposure to both developed markets and emerging markets. The Fund will use a combination of systematic (i.e. rule based) models and discretionary investment techniques to allocate assets.
- The Fund may invest up to 10% of its Net Asset Value in asset-backed securities and mortgage-backed securities (whether investment grade or not).
- The Investment Adviser (IA) may use financial derivative instruments (FDIs) (i.e. investments the prices of which are based on one or more underlying assets) for investment purposes in order to achieve the investment objective of the Fund, for efficient portfolio management and/or to reduce risk within the Fund's portfolio, reduce investment costs and generate additional income. The Fund may, via FDIs, generate varying amounts of market leverage (i.e. where the Fund gains market exposure in excess of the value of its assets).
- The Fund is actively managed, and the IA has discretion to select the Fund's investments and is not constrained by any benchmark in this process. The ICE BofA 3 Month Treasury Bill Index (the "Benchmark") should be used by shareholders to compare the performance of the Fund. Investors may also use a composite benchmark comprising 60% of the MSCI World Index and 40% of Bloomberg Global Aggregate Index to compare the performance of the Fund (the "Composite Benchmark"). The components of the Composite Benchmark may be quoted separately in marketing materials related to the Fund.
- The Fund invests in FIS whose prices may be affected by changing interest rates which in turn may affect the value of your investment. FIS prices move inversely to interest rates. Therefore, the market value of FIS may decrease as interest rates increase. The credit rating of an issuing entity will generally affect the yield that can be earned on FIS, the better the credit rating the smaller the yield.
- The price of equity securities fluctuates daily and may be influenced by factors affecting the performance of the individual companies issuing the equities, as well as by daily stock market movements, and broader economic and political developments which in turn may affect the value of your investment.
- The return on your investment in the Fund is directly related to the value of the underlying assets of the Fund, less costs (see "What are the costs?" below).
- The relationship between the return on your investment, how it is impacted and the period for which you hold your investment is considered below (see "How long should I hold it and can I take my money out early?").
- The depositary of the Fund is State Street Bank International GmbH, Luxembourg Branch.

- Your shares will be non-distributing (i.e. dividend income will be included in their value).
- Your shares will be denominated in US Dollar, the Fund's base currency.
- You can buy and sell your shares daily. The minimum initial investment for this share class is US\$10,000,000 or other currency equivalent.

Intended retail investor: The Fund is intended for retail investors with the ability to bear losses up to the amount invested in the Fund (see "How long should I hold it and can I take my money out early?").

Insurance benefits: The Fund does not offer any insurance benefits.

What happens if BlackRock (Luxembourg) S.A. is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary, State Street Bank International GmbH, Luxembourg Branch (the "Depositary"). In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations). As a shareholder of the Fund you would not be able to make a claim to the UK Financial Services Compensation Scheme or any other scheme about the Fund in the event that the Fund is unable to pay out.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time: The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does.
