

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

iShares USD Sukuk Index Fund (IE) (the "Fund"), **Class Flexible Accu GBP** (the "Share Class"), ISIN: **IE000RAHCAJ4**, is authorised in Ireland and manufactured by BlackRock Asset Management Ireland Limited (the "Manager") which is part of the BlackRock, Inc group.

The Manager is authorised in Ireland and regulated by the Central Bank of Ireland (the "CBI") and the CBI is responsible for supervising the Manager in relation to this Key Information Document.

What is this product?

Type: The Fund is a sub-fund of BlackRock Fixed Income Dublin Funds plc, an umbrella company incorporated in Ireland, authorised by the Central Bank of Ireland as a Undertaking for Collective Investment in Transferable Securities ("UCITS").

Term: The Fund does not have a fixed term of existence or maturity period but in certain circumstances, as described in the Fund prospectus, the Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

Objectives

- The Fund aims to achieve a total return on your investment, through a combination of capital growth and income, which reflects the return of the J.P. Morgan EM Aggregate Sukuk Index (12pm UK), the Fund's benchmark index (Index).
- The Fund is passively managed and invests, in a manner consistent with the rules, principles and parameters of Islamic law (Shari'ah) in a portfolio of Sukuk (defined below) that, as far as possible and practicable, consists of the component securities of the Index.
- The Index measures the performance of US Dollar denominated emerging market investment certificates commercially similar to fixed income securities that are commonly used by investors wishing to comply with Shari'ah (Sukuk) issued by sovereign, quasi-sovereign, corporate and supranational entities. The Index may consist of investment grade, non-investment grade and unrated Sukuk issued by sovereign, quasi-sovereign, corporate and supranational entities, that comply with the minimum issue size and remaining maturity requirements of the Index.
- The Fund intends to use optimisation techniques in order to achieve a similar return to the Index and it is therefore not expected that the Fund will hold each and every underlying constituent of the Index at all times or hold them in the same proportion as their weightings in the Index.
- The Fund may invest in Shari'ah-compliant financial derivative instruments (FDIs) (i.e. investments the prices of which are based on one or more underlying assets), including Wa'd currency futures, for efficient portfolio management purposes.
- The Fund's investments will normally be listed or traded on Regulated Markets.
- The Fund may hold some securities which are not underlying constituents of the Index where such securities provide similar performance (with matching risk profile) to the Index, provided that such action is undertaken in compliance with Shari'ah principles.
- The Fund may hold small amounts of cash, which holdings are held in a non-interest-bearing account.
- This Fund is designed for investors wishing to comply with Shari'ah. However, subscription is open to any other investor who is interested in investing in the Fund. It is intended that all the investments made by this Fund take place in conformity with Shari'ah. It is possible that the application of Shari'ah may result in different outcomes for the Fund than in the case of funds with similar objectives that are not compliant with Shari'ah.
- The price of Sukuk may be affected by changing interest rates which in turn may affect the value of your investment. Sukuk prices move inversely to interest rates. Therefore, the market value of Sukuk may decrease as interest rates increase. The credit rating of an issuing entity will generally affect the yield that can be earned on Sukuk; the better the credit rating the smaller the yield.
- The return on your investment in the Fund is directly related to the value of the underlying assets of the Fund, less costs (see "What are the costs?" below).
- The relationship between the return on your investment, how it is impacted and the period for which you hold your investment is considered below (see "How long should I hold it, and can I take my money out early?").
- The price of a derivative changes on a daily basis depending on the value of the underlying reference asset(s) which in turn may affect the value of your investment. A change in the value of underlying reference assets can have a greater impact on the value of derivatives than if the assets were held directly since derivatives can be more sensitive to changes in the value of underlying reference assets.
- The depositary of the Fund is J.P. Morgan SE – Dublin Branch.

- The Fund's base currency is US Dollar. Shares for this class are bought and sold in Sterling. The performance of your shares may be affected by this currency difference.
- You can buy and sell your shares daily. The minimum initial investment for this share class is £500,000.

Intended retail investor: The Fund is intended for retail investors with the ability to bear losses up to the amount invested in the Fund (see "How long should I hold it and can I take my money out early?").

Insurance benefits: The Fund does not offer any insurance benefits.

What happens if BlackRock Asset Management Ireland Limited is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary, J.P. Morgan SE – Dublin Branch (the "Depositary"). In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations). As a shareholder of the Fund you would not be able to make a claim to the UK Financial Services Compensation Scheme or any other scheme about the Fund in the event that the Fund is unable to pay out.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time: The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.
