What were the Fund costs for the last year?

How did the Fund perform last year?

- For the reporting period ended December 31, 2024, the Fund's Institutional Shares returned 0.46%.
- For the same period, the Bloomberg Global Aggregate Bond Index returned (1.69)% and the Custom Benchmark returned (1.55)%.

What contributed to performance?

Positive contributions to the Fund's performance over the period were led by positioning with respect to U.S. interest rates, followed by allocations to non-U.S. corporate bonds and structured products.

What detracted from performance?


The Fund's positioning with respect to both developed and emerging market currencies detracted from performance, along with its stance with respect to developed international market interest rates.
