- The Fund aims to achieve a total return on your investment, through a combination of capital growth and income, which reflects the return of the FTSE Non-EGBI Euro Broad Investment-Grade Index, the Fund's benchmark index.
- The Fund invests predominantly in the fixed income securities (FI) securities (such as bonds) that make up the Fund's benchmark index (which comprises nongovernment bonds).
- The FI securities may be issued by companies and to a lesser extent by governments, government agencies and supranationals (e.g. the International Bank for Reconstruction and Development) domiciled in and outside the European Union.

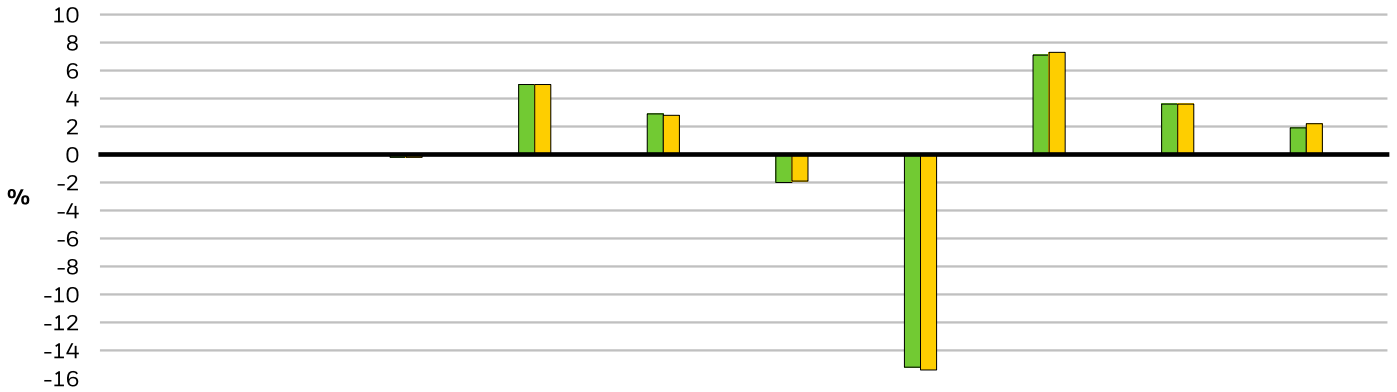

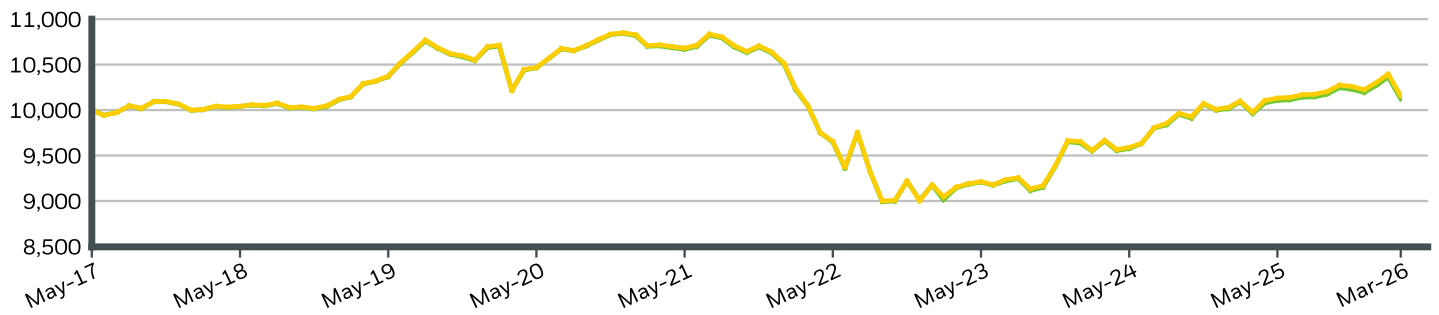

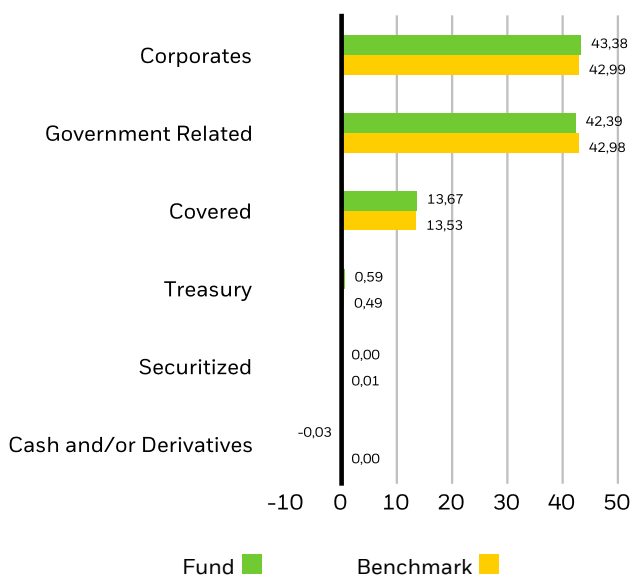

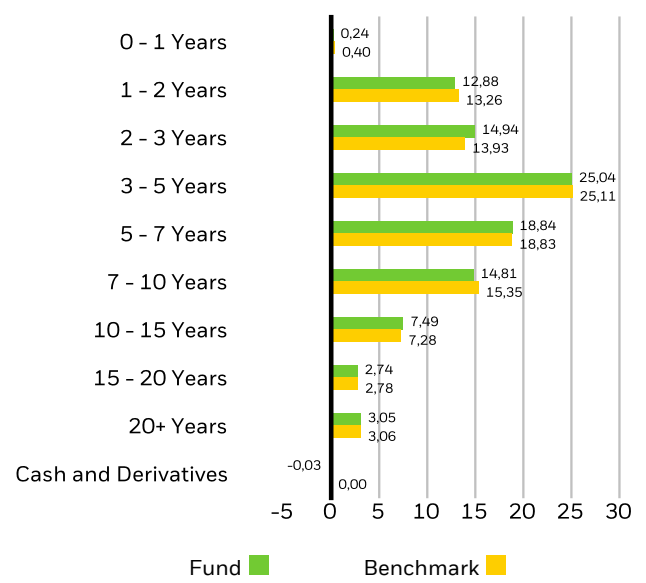

#### SECTOR BREAKDOWN (%)



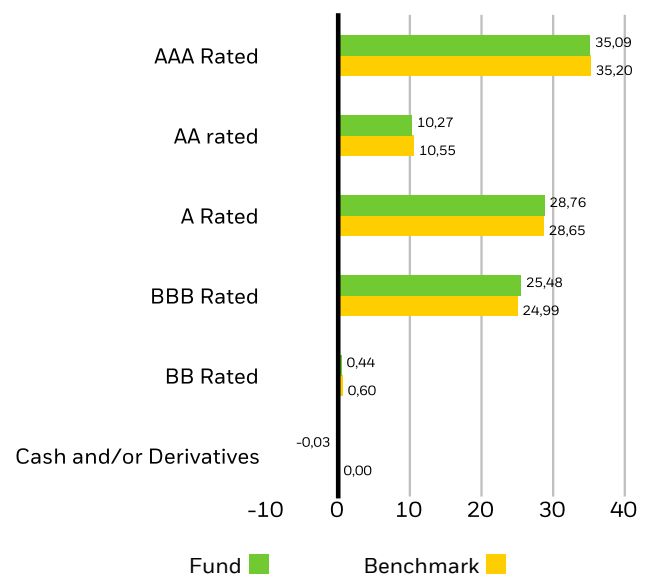

#### GLOSSARY

**SFDR Classification: Article 8:** Products that promote environmental or social characteristics and promote good governance practices.

**Analyst Driven %<sup>i</sup>** is the analyst input into the overall rating assignment, including direct analyst coverage and inheritance of an analyst-rated pillar

**Yield to Maturity:** Yield to Maturity (YTM) is the discount rate that equates the present value of bond's cash flows with its market price (including accrued interest). The fund YTM is the weighted average of fund's individual bond holding YTM's based upon Net Asset Value ('NAV'). The measure does not include fees and expenses. For callable bonds, YTM is the Yield-to-Worst.

**Effective Duration:** Effective duration is a measure of a fund's interest-rate sensitivity. Put simply, the longer a fund's duration, the more sensitive the fund is to shifts in interest rates. So a fund with a duration of 10 years is twice as volatile as a fund with a five-year duration.
