| <b>WHAT ARE YOU INVESTING IN?</b> <ul style="list-style-type: none"> <li>You are investing in an exchange traded fund constituted as a sub-fund of an umbrella unit trust in Singapore.</li> <li>The investment objective of the Fund is to track the performance of the Index in US dollar terms.</li> <li>The Index is designed to exceed the minimum requirements of the European Union (“EU”) Climate Transition Benchmarks (“CTBs”) while applying specific controversial business involvement or fossil fuel-based exclusions and maintaining an ESG score that is equivalent or higher than the MSCI India Index.
