INVESTMENT STRATEGY

The Fund will seek to provide a combination of income and capital growth by investing in a portfolio of debt securities, across multiple fixed income sectors and instruments, using model-based asset allocation and security selection models. The Fund will select corporate bonds of companies to seek to generate alpha and positive aggregate societal impact outcomes, as determined by BlackRock, compared to the Bloomberg U.S. Aggregate Bond Index.

As a result of the reorganization, the Fund adopted the performance and financial history of the predecessor fund.

The excess return of the fund relative to the return of the benchmark index is a fund's alpha.
