

Debt Strategies Fund, Inc. seeks to provide current income by investing primarily in a diversified portfolio of U.S. companies' debt instruments, including corporate loans, that are rated in the lower rating categories of the established rating services (Baa or lower by Moody's Investors Service, Inc. or BBB or lower by Standard & Poor's) or unrated debt instruments of comparable quality. As a secondary objective, the Fund will seek capital appreciation.



## GLOSSARY

**Distribution Rate:** Distribution Rate is calculated by dividing the last distribution per share (annualized) by market price. **Yield to Maturity:** The discount rate that equates the present value of a bond's cash flows with its market price (including accrued interest). The

**Total Leverage:** The amount of borrowed funds used to purchase assets in order to enhance returns.

**Percent Leveraged:** Percent Leveraged represents the amount of preferred stock or tender option bonds issued in relation to total Managed Assets.

**Modified Duration:** A measure of the responsiveness of a bond's or portfolio's price to changes in interest rates. Effective Duration adjusts for changes in projected cash flows as a result of interest rate changes. This metric considers the likelihood that bonds will be called or prepaid before the scheduled maturity date.

Yield to Maturity: The discount rate that equates the present value of a bond's cash flows with its market price (including accrued interest). The Fund average YTM is the weighted average of the fund's individual bond holding YTMs based on NAV. The measure does not include fees and expenses. For callable bonds, YTM is yield-to-worst

**WAL to Worst:** The weighted average time to receipt of principal, adjusting for embedding optionality.

Yield to Worst: The average rate of return of the portfolio at current market prices, adjusting for optionality.
