

MODERATE TARGET-RISK 529 OPTION

Investment Approach

Seeks a balance between long-term capital appreciation and high current income, with a greater emphasis on capital appreciation. Normally invests 60% of its assets in underlying funds that invest primarily in equity securities and 40% of its assets in underlying funds that invest primarily in fixed income securities.

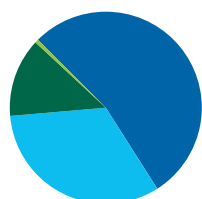
